

THE SECURITIES ACT (UNITED STATES ISSUERS EMPLOYEE STOCK PURCHASE PLANS) EXEMPTION NOTICE 1991, AMENDMENT NO. 13

PURSUANT to the Securities Act 1978, the Securities Commission gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Securities Act (United States Issuers Employee Stock Purchase Plans) Exemption Notice 1991, Amendment No. 13, and shall be read together with and deemed part of the Securities Act (United States Issuers Employee Stock Purchase Plans) Exemption Notice 1991* (hereinafter referred to as the principal notice).
- (2) This notice shall come into force on the day after the date of its notification in the Gazette.
- 2. New Schedule substituted—The principal notice is hereby amended by revoking the Schedule thereto (as substituted by the Securities Act (United States Issuers Employee Stock Purchase Plans) Exemption Notice 1991, Amendment No. 10 and amended by the Securities Act (United States Issuers Employee Stock Purchase Plans) Exemption Notice 1991, Amendment No. 11 and the Securities Act (United States Issuers Employee Stock Purchase Plans) Exemption Notice 1991, Amendment No. 12), and substituting the Schedule set out in the First Schedule to this notice.
