PURSUANT to the Securities Act 1978, the Securities Commission gives the following notice.

NOTICE

**1. Title and commencement**—(1) This notice may be cited as the Securities Act (United States Issuers Employee Stock Purchase Plans) Exemption Notice 1991, Amendment No. 9, and shall be read together with and deemed part of the Securities Act (United States Issuers Employee Stock Purchase Plans) Exemption Notice 1991\* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

**2. Schedule amended**—The Schedule to the principal notice (as substituted by the Securities Act (United States Issuers Employee Stock Purchase Plans) Exemption Notice 1991, Amendment No. 7 and amended by the Securities Act (United States Issuers Employee Stock Purchase Plans) Exemption Notice 1991, Amendment No. 8), is hereby amended by—

- (a) Inserting in the first column, in its appropriate alphabetical order, the name “Citicorp” and opposite it, in the second column, the names “Citibank, N.A. New Zealand Branch” and “Citicorp New Zealand Limited”; and
- (b) Omitting from the first column the name “IMCERA Group Inc.”, and substituting the name “Mallinckrodt Group Inc.”.

EXPLANATORY NOTE

*This note is not part of the notice, but is intended to indicate its general effect.*

This notice, which comes into force on the day after the date of its notification in the *Gazette*, adds Citicorp to the list of designated issuers in the Schedule to the Securities Act (United States Issuers Employee Stock Purchase Plans) Exemption Notice 1991. The notice also omits the name IMCERA Group Inc. from the Schedule and substitutes the name Mallinckrodt Group Inc. as a result of a change of name.
