

SECURITIES ACT (AUSTRALIAN UNIT TRUSTS) EXEMPTION AMENDMENT NOTICE (NO. 2) 1997

PURSUANT to the Securities Act 1978, the Securities Commission gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Securities Act (Australian Unit Trusts) Exemption Amendment Notice (No. 2) 1997, and is part of the Securities Act (Australian Unit Trusts) Exemption Notice 1996* ("the principal notice").
- (2) This notice comes into force on the day after the date of its notification in the Gazette.
- 2. New Schedule substituted—The principal notice is amended by revoking the Schedule (as substituted by the Securities Act (Australian Unit Trusts) Exemption Notice 1996, Amendment No. 1 and amended by the Securities Act (Australian Unit Trusts) Exemption Notice 1996, Amendment No. 2, the Securities Act (Australian Unit Trusts) Exemption Notice 1996, Amendment No. 3, and the Securities Act (Australian Unit Trusts) Exemption Amendment Notice 1997), and substituting the Schedule set out in Schedule 1.
 - 3. Revocations—The notices specified in Schedule 2 are revoked.
