



**THE SECURITIES ACT (AUSTRALIAN UNIT TRUSTS)
EXEMPTION NOTICE 1996, AMENDMENT NO. 1**

PURSUANT to the Securities Act 1978, the Securities Commission gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Securities Act (Australian Unit Trusts) Exemption Notice 1996, Amendment No. 1, and shall be read together with and deemed part of the Securities Act (Australian Unit Trusts) Exemption Notice 1996* (hereinafter referred to as the principal notice).

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

2. New Schedule to principal notice—The principal notice is hereby amended by revoking the Schedule thereto, and substituting the Schedule set out in the Schedule to this notice.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on the day after the date of its notification in the *Gazette*, substitutes a new Schedule of Australian issuers in the Securities Act (Australian Unit Trusts) Exemption Notice 1996.
