

## THE SEAT BELTS APPROVAL NOTICE 1974

Pursuant to regulation 49 of the Traffic Regulations 1956\* (as substituted by regulation 14 (1) of the Traffic Regulations 1956, Amendment No. 7), the Secretary for Transport hereby gives the following notice.

## NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Seat Belts Approval Notice 1974.
  - (2) This notice shall come into force on the 1st day of January 1975.
- 2. Approval of seat belts—The following types of seat belts are hereby approved for the purposes of regulation 51B of the Traffic Regulations 1956 (as substituted by regulation 2 of the Traffic Regulations 1956, Amendment No. 28), namely:
  - (a) Seat belts bearing a standard mark as defined in section 2 of the Standards Act 1965:
  - (b) Seat belts bearing the certification mark of the British Standards Institute:
  - (c) Seat belts manufactured in Australia and bearing the standard number "E 35" of the Australian Standards Association:
  - (d) Seat belts labelled or otherwise marked that they comply with Federal Motor Vehicle Safety Standard No. 209 of the United States of America:
  - (e) Seat belts complying with E.C.E. regulation No. 16 and labelled or otherwise marked accordingly.
