

THE SCHOOL BOARDING BURSARIES REGULATIONS 1972, AMENDMENT NO. 4

ORDER IN COUNCIL

At the Government House at Wellington this 17th day of September 1979 Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the School Boarding Bursaries Regulations 1972, Amendment No. 4, and shall be read together with and deemed part of the School Boarding Bursaries Regulations 1972* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the

date of their notification in the Gazette.

2. Pro rata payments—The principal regulations are hereby amended by inserting, after regulation 7, the following regulations—

"7A. (1) Without limiting the generality of regulation 7 of these regulations, the Minister may authorise the award of bursaries to pupils, or classes of pupils, who are not required to live away from home on a full-time basis.

"(2) Notwithstanding anything in these regulations, the amount payable during any term to the holder of a bursary who is not required to live away from home on a full-time basis shall be calculated at the rate of 1.5 percent of the amount that would be payable to him per term if he were so required, for every night upon which he is required to live away from home."

3. Termination of bursary—The principal regulations are hereby further amended by revoking regulation 13, and substituting the following regulation:

"13. (1) Subject to subclause (2) of this regulation, the award of a

bursary shall be terminated if-

"(a) The bursar transfers from the school shown in his application for it to another school; or

"(b) The bursar has ceased to be eligible for the award of the bursary

by reason of-

"(i) A change in the location of his home; or

"(ii) The opening of a State school in the vicinity of his

home; or "(iii) The commencement of a transport service with a point of embarkation in the vicinity of his home from which

he can be carried to the school at which he is boarding. "(2) The termination under subclause (1) of this regulation of any

bursary shall take effect—

"(a) At the end of the current school year in the case of a bursar enrolled in Form V, Form VI, or Form VII; and

"(b) At the end of the current school term in every other case.

"(3) Where the award of a bursary is, or is about to be, terminated under this regulation, the bursar may at any time, if he still is, or becomes, eligible for the award of a bursary, apply again for the award of a bursary.'

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations make 2 amendments to the principal regulations.

First they allow the payment of a bursary on a pro rata basis to oupils required to live away from home otherwise than on a full-time basis.

Secondly, they amend the provisions of the principal regulations relating to the termination of bursaries. At present a bursary is terminated when a transport service commences that enables the bursar to attend the nearest State school. In future the commencement of a transport service will terminate the award of a bursary only where it enables the bursar to attend the school at which he is boarding.
