THE SCHOOL COMMITTEES ADMINISTRATION REGULATIONS 1965, AMENDMENT NO. 6

ORDER IN COUNCIL

At the Government House at Wellington this 5th day of October 1981

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the School Committees Administration Regulations 1965, Amendment No. 6, and shall be read together with and deemed part of the School Committees Administration Regulations 1965* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 14th day after the date of their notification in the *Gazette*.

2. Members to be elected—The principal regulations are hereby amended by revoking regulation 5, and substituting the following regulation:

"5. (1) Subject to subclauses (2) and (3) of this regulation, the members of each School Committee for a school district of a State primary school other than an intermediate school shall be elected at the biennial meeting of householders in the school district.

"(2) Where a school district is constituted for a newly established school, the Board shall, unless it appoints one or more Commissioners in accordance with regulation 15 of these regulations, fix a time and place for the first election of members of the School Committee for that district.

"(3) If the time for the first election of members of a School Committee fixed under subclause (2) of this regulation is less than one year before the

date of the next biennial meeting of householders in the school district concerned, the members elected at that first election shall continue in office until the following biennial meeting of householders."

3. Amendments consequential on abolition of Maori schools— (1) Regulation 6 (2) of the principal regulations is hereby amended by omitting the words ", or (in the case of the school districts of Maori schools) the Director-General,".

(2) Regulation 13 (1) of the principal regulations is hereby amended by omitting the words "(or, in the case of the Committee for the school district of a Maori school, to the judgment of the Director-General)".

(3) Regulation 13 (2) of the principal regulations is hereby amended by omitting the words "or to the Director-General", "or Director-General, as the case may be,", and "or his".

(4) Regulation 14 of the principal regulations is hereby amended by omitting the words "or, in the case of the school district of a Maori school, the Director-General if he thinks fit,".

(5) Regulation 15 of the principal regulations is hereby amended by omitting the words "or the Director-General" and "or the Director-General, as the case may be".

(6) Regulation 16 of the principal regulations is hereby amended by omitting the words "(or, in the case of the school district for a Maori school, the Director-General, if he thinks fit)".

(7) Regulation 18 of the principal regulations is hereby amended by omitting the words "or to the Director-General, as the case may be, the Board or Director-General", and substituting the words ", the Board".

(8) Regulation 26 (1) of the principal regulations is hereby amended by omitting the words "or (in the case of a Committee for the school district of a Maori school) by the Director-General".

(9) Regulation 30 (2) of the principal regulations is hereby amended by omitting the words ", in the case of Committees of State primary schools other than Maori schools," and "and, in the case of Committees of Maori schools, by the Director-General".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

This amendment has two effects. First, it provides that where a new School Committee has been in office for less than a year before the biennial meeting of householders in its district, its members are to continue in office until the next such meeting. Secondly, it omits references to Maori schools, which have been abolished.
