

THE SPRAY COATING REGULATIONS 1962, AMENDMENT NO. 2

ORDER IN COUNCIL

At the Government House at Wellington this 21st day of December 1981

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to-

- (a) The Health Act 1956 in relation to regulations 1 and 3; and
- (b) The Factories and Commercial Premises Act 1981 in relation to regulations 1 to 3—

His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Spray Coating Regulations 1962, Amendment No. 2, and shall be read together with and deemed part of the Spray Coating Regulations 1962* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 1st day of February 1982.
- 2. Offences—The principal regulations are hereby amended by inserting, after regulation 40, the following regulation:
- "40A. Every person commits an offence against these regulations, and shall be liable on summary conviction to the penalties provided in that behalf in section 62 (1) (b) of the Factories and Commercial Premises Act 1981, who—

- "(a) Acts in contravention of, or fails or refuses duly and faithfully to observe or comply with, any requirement, obligation, rule, or provision, imposed or enacted, or required to be observed, under these regulations; or
- "(b) Introduces any food or drink into, or keeps, prepares, or partakes of any food or drink in, a room booth or in any room in which any other booth is situated; or
- "(c) Tests a spray gun by spraying indiscriminately about a workroom or booth; or
- "(d) Directs a spray gun to spray on the interior lining of a booth; or
- "(e) In the circumstances for which any protective clothing, face mask, or respirator, is provided pursuant to these regulations, fails or refuses to wear that clothing, mask, or respirator."
- **3. Revocations**—Regulations 41 and 42 of the principal regulations are hereby revoked.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 February 1982 (the commencement of the Factories and Commercial Premises Act 1981), amend the offence provisions of the Spray Coating Regulations 1962 so as to omit all references to the amount of penalties. The effect is that the penalties will be those provided in that Act.
