THE STOCK (JOHNE'S DISEASE) REGULATIONS, 1936.

Enacting authority: His Excellency the Governor-General in Council.

Act pursuant to which the regulations were made: The Stock Act,
1908.

Date on which the regulations were made: 9th day of September, 1936.

Date of notification in Gazette: 10th day of September, 1936.

REGULATIONS.

1. Preliminary.

- (1) These regulations may be cited as the Stock (Johne's Disease) Regulations, 1936.
- (2) These regulations shall come into force on the day following notification in the *Gazette* of the making hereof.
 - (3) In these regulations, unless inconsistent with the context,—
 "The said Act" means the Stock Act, 1908:

The terms "cattle," "Inspector," "land," and "owner" have the respective meanings assigned to them by the said Act.

2. Examination and Treatment of Cattle on certain Lands.

- (1) In any case in which an Inspector is satisfied or has reasonable ground for suspecting that Johne's disease exists among cattle on any land the Inspector may by notice in writing given to the owner require the owner to muster his cattle at such time and place as the Inspector in such notice may appoint in order that the same may be inspected and examined.
- (2) Such examination may include any of the diagnostic methods or means of treatment used in veterinary practice and in particular the application of the Johnin test to such cattle, which test shall be carried out only by a Government Veterinarian.
- (3) If on such examination any animal reacts to the Johnin test, or if in the opinion of the examining veterinarian any animal is diseased, such animal shall be condemned and destroyed or otherwise dealt with as the examining veterinarian shall direct.

3. Removal of Cattle from the North Island to any other ${\bf Part}$ of New Zealand.

- (1) In this regulation the term "dairy cattle" means cattle of any of the dairy breeds of cattle which are of not less age than six months.
- (2) No person shall ship any dairy cattle from any port in the North Island to any port in the South Island except in pursuance of a permit granted pursuant to these regulations.

(3) No person shall ship any dairy cattle from any port in the North Island to any port in the South Island except at the port and within the time specified in a permit issued pursuant to these regulations.

(4) Every owner of dairy cattle who desires to ship any such cattle to any port in the South Island shall, not less than fourteen days before the date of the proposed removal of such cattle from land in his occupation, make application in writing to the Inspector of Stock for the district within which the cattle are depastured or kept for a permit to ship such cattle, and shall in such application specify the farm or place where such cattle may be inspected and examined.

(5) As soon as practicable after the receipt of an application pursuant to the last preceding clause of this regulation, an Inspector, being a Government Veterinarian, shall proceed to the farm or place mentioned in such application for the purpose of inspecting and

examining such dairy cattle.

(6) In inspecting and examining any dairy cattle pursuant to an application made under clause 4 of this regulation the examining veterinarian may employ any of the diagnostic methods used in veterinary practice and in particular may apply the Johnin or other test to such cattle.

(7) If on such examination any animal reacts to the Johnin or other test, or if in the opinion of the examining veterinarian any animal is diseased, such animal shall be condemned and destroyed or otherwise dealt with as the examining veterinarian shall direct.

(8) If in the opinion of the examining veterinarian the dairy cattle mentioned in such application are not diseased he shall issue or cause to be issued to the owner of such dairy cattle a permit in or to the effect of the form in the Schedule hereto authorizing the shipment of such dairy cattle to the South Island.
