ORDER IN COUNCIL

At Wellington this 12th day of April 1999

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to section 30A of the State-Owned Enterprises Act 1986, His Excellency the Governor-General, acting—

- (a) By and with the advice and consent of the Executive Council; and
- (b) On the recommendation of the Minister for State-Owned Enterprises, that Minister being satisfied—
  - (i) That the name of the State enterprise known as Hydro Energy Limited has been changed to Meridian Energy Limited; and
  - (ii) That a certificate of incorporation recording the change of name and dated 17 March 1999 has been issued to that State enterprise under section 23 (3) (b) of the Companies Act 1993,—makes the following order.

 ORDER

**1. Title and commencement**—(1) This order may be cited as the State-Owned Enterprises (Meridian Energy Limited) Order 1999.

(2) This order comes into force on the day after the date of its notification in the *Gazette*.

**2. Amendment to First and Second Schedule of State-Owned Enterprises Act 1986**—The State-Owned Enterprises Act 1986 is amended by omitting from the First Schedule, and also from the Second Schedule, the words “Hydro Energy Limited”, and substituting in each case the words “Meridian Energy Limited”.

**3. Amendment to First Schedule of Ombudsmen Act 1975**—The Ombudsmen Act 1975 is amended by omitting from Part II of the First Schedule the words “Hydro Energy Limited”, and substituting the words “Meridian Energy Limited”.

**4. Amendment to Schedule 18 of Income Tax Act 1994**—The Income Tax Act 1994 is amended by omitting from Schedule 18 the words “Hydro Energy Limited”, and substituting the words “Meridian Energy Limited”.

 EXPLANATORY NOTE

*This note is not part of the order, but is intended to indicate its general effect.*

This order, which comes into force on the day after the date of its notification in the *Gazette*, amends a number of Acts by changing references to the name of a State enterprise to reflect the change in the name of the State enterprise from Hydro Energy Limited to Meridian Energy Limited.
