



State-Owned Enterprises (Landcorp Farming Limited) Order 2001

Order in Council

Pursuant to section 30A of the State-Owned Enterprises Act 1986, His Excellency the Governor-General makes the following order, acting—

- (a) on the advice and with the consent of the Executive Council; and
- (b) on the recommendation of the Minister for State-Owned Enterprises, who is satisfied that—
 - (i) the name of the State enterprise known as Land Corporation Limited has been changed to Landcorp Farming Limited; and
 - (ii) a certificate of incorporation recording that change of name and dated 15 November 2000 has been issued to that State enterprise under section 23(3)(b) of the Companies Act 1993.

1 Title

This order is the State-Owned Enterprises (Landcorp Farming Limited) Order 2001.

2 Commencement

This order comes into force on the 28th day after the date of its notification in the *Gazette*.

3 Amendment to State-Owned Enterprises Act 1986

The State-Owned Enterprises Act 1986 (1986 No 124) is amended by omitting from the First Schedule and the Second Schedule the words “Land Corporation Limited”, and substituting in each case the words “Landcorp Farming Limited”.

4 Amendment to other enactments

The enactments specified in the Schedule are amended in the manner indicated in that schedule.

Conservation Act 1987 (1987 No 65)

Omit from section 24(7) the words “Land Corporation Limited” and substitute the words “Landcorp Farming Limited”.

Omit from section 64(4A) the words “Land Corporation Limited” and substitute the words “Landcorp Farming Limited”.

Income Tax Act 1994 (1994 No 164)

Omit from Schedule 18 the words “Land Corporation Limited” and substitute the words “Landcorp Farming Limited”.

Part 1—*continued***Maori Affairs Restructuring Act 1989** (1989 No 68)

Omit from section 76(1) in both places where they occur the words “Land Corporation Limited” and substitute in each case the words “Landcorp Farming Limited”.

Ngai Tahu Claims Settlement Act 1998 (1998 No 97)

Omit from paragraph (a)(iv) of the definition of the term **dispose of relevant land** in section 48 in both places where they occur the words “Land Corporation Limited” and substitute in each case the words “Landcorp Farming Limited”.

Omit from paragraph (c)(iv) of the definition of the term **relevant land** in section 48 the words “Land Corporation Limited” in both places where they occur and substitute in each case the words “Landcorp Farming Limited”.

Official Information Act 1982 (1982 No 156)

Omit from the First Schedule the words “Land Corporation Limited” and substitute the words “Landcorp Farming Limited”.

Ombudsmen Act 1975 (1975 No 9)

Omit from Part II of the First Schedule the words “Land Corporation Limited” and substitute the words “Landcorp Farming Limited”.

Public Trust Office Act 1957 (1957 No 36)

Omit from section 33(1), (6), and (8) the words “Land Corporation Limited” and substitute in each case the words “Landcorp Farming Limited”.

Omit from paragraph (b) of the definition of the term **leasing authority** in section 33(2) in both places where they occur the words “Land Corporation Limited” and substitute in each case the words “Landcorp Farming Limited”.

Real Estate Agents Act 1976 (1976 No 9)

Omit from section 3(2)(d) the words “Land Corporation Limited” and substitute the words “Landcorp Farming Limited”.

State-Owned Enterprises Amendment Act 1992 (1992 No 27)

Omit from the heading before section 13 the words “Land Corporation Limited” and substitute the words “Landcorp Farming Limited”.

Omit from section 13 and the heading to that section in each place where they occur the words “Land Corporation Limited” and substitute in each case the words “Landcorp Farming Limited”.

Part 1—continued**Survey Act 1986** (1986 No 123)

Omit from section 75 the words “Land Corporation Limited” and substitute the words “Landcorp Farming Limited”.

Part 2**Regulation amended****State-Owned Enterprises (Landcorp) Order 1989**

(SR 1989/178)

Omit from clause 2 in both places where they occur the words “Land Corporation Limited” and substitute in each case the words “Landcorp Farming Limited”.

Explanatory note

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force on the 28th day after the date of its notification in the *Gazette*, amends a number of enactments by changing references to the name of a State enterprise to reflect the change in the name of the State enterprise from Land Corporation Limited to Landcorp Farming Limited.
