THE SHIPPING (FEES FOR EXAMINATION OF PLANS OF SHIPS AND INSPECTION BY SURVEYORS) NOTICE 1971

PURSUANT to the Shipping and Seamen Act 1952, the Minister of Marine, hereby gives the following notice.

NOTICE

1. Title and commencement—(1) This notice may be cited as the Shipping (Fees for Examination of Plans of Ships and Inspection by Surveyors) Notice 1971.

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

2. Fee for examination of plans of ships—The fee payable under section 196 of the Shipping and Seamen Act 1952 (as substituted by section 12 of the Shipping and Seamen Amendment Act (No. 2) 1970) for the examination of the plans and specifications of a ship shall be the appropriate fee specified in the First Schedule to this notice.

3. Fee for attendance and inspection by Surveyor during construction—(1) The fee payable under the said section 196 of the Shipping and Seamen Act 1952 for the attendance of and inspection by a Surveyor during the construction of a ship shall be the appropriate fee specified in the Second Schedule to this notice.

(2) The said fee shall be payable irrespective of the total number of visits or the total time spent by a surveyor during the construction of the ship.

4. Revocation—The Shipping (Fee for Examination of Plans of Ships) Notice 1970* is hereby revoked.
