## **Notice**

## 1 Title

TD:-1

This notice is the Sports Fish Licences, Fees, and Forms Notice 2003.

### 2 Commencement

This notice comes into force on 1 October 2003.

## 3 Interpretation

In this notice, unless the context otherwise requires,—

**24-hour licence** means a licence that entitles the holder to fish for sports fish during any 24-hour period specified in the licence in—

- (a) the region for which the licence is issued; and
- (b) all other regions (excluding the Taupo District)

**48-hour licence** means a licence that entitles the holder to fish for sports fish during any 48-hour period specified in the licence in—

- (a) the region for which the licence is issued; and
- (b) all other regions (excluding the Taupo District)

**adult** means a person aged 20 years or older on 1 October 2003

**child** means a person aged under 12 years on 1 October 2003 **family** means—

- (a) 1 person, or 1 person and that person's partner; and
- (b) the dependents of that person or those persons who—
  - (i) ordinarily or periodically reside with that person or those persons; and
  - (ii) are aged under 20 years on 1 October 2003; and
- (c) the grandchildren of that person or those persons who are aged under 20 years on 1 October 2003

## family licence means a licence that entitles—

- (a) the holder of the licence to fish for sports fish in the period beginning on 1 October 2003 and ending on 30 September 2004 in—
  - (i) the region for which the licence is issued; and
  - (ii) all other regions (excluding the Taupo District); and
- (b) the other members of the holder's family who are named in the licence to fish for sports fish during that period and in the permitted regions, but only if accompanied by the holder

**junior** means a person aged 12 years or over, but under 16 years, on 1 October 2003

**licence** means any class of licence to fish for sports fish **partner**, in relation to a person, means—

- (a) any other person to whom the person is legally married:
- (b) any other person (whether of the same or the opposite gender) with whom the person lives in a relationship in the nature of marriage (although those persons are not, or were not, or are not or were not able to be, legally married to each other)

weekly licence means a licence that entitles the holder to fish for sports fish during any 7-day period specified in the licence in—

- (a) the region for which the licence is issued; and
- (b) all other regions (excluding the Taupo District)

whole-season licence means a licence that entitles the holder to fish for sports fish in the period beginning on 1 October 2003 and ending on 30 September 2004 in—

- (a) the region for which the licence is issued; and
- (b) all other regions (excluding the Taupo District)

winter licence means a licence that entitles the holder to fish for sports fish in the period beginning on 1 April 2004 and ending on 30 September 2004 in—

- (a) the region for which the licence is issued; and
- (b) all other regions (excluding the Taupo District)

**young adult** means a person aged 16 years or over, but under 20 years, on 1 October 2003.

## Eligibility for sports fish licences and fees

## 4 Fish and game councils may issue licences

A fish and game council may issue 1 or more of the following classes of licence:

- (a) 24-hour licence:
- (b) 48-hour licence:
- (c) family licence:
- (d) weekly licence:
- (e) whole-season licence:
- (f) winter licence.

### 5 24-hour licence

If a fish and game council issues 24-hour licences, an adult, a junior, or a young adult may obtain a 24-hour licence from that council on payment of the appropriate fee specified in Part 1 of the Schedule.

#### 6 48-hour licence

If a fish and game council issues 48-hour licences, an adult, a junior, or a young adult may obtain a 48-hour licence from that council on payment of the appropriate fee specified in Part 2 of the Schedule.

## 7 Family licence

If a fish and game council issues family licences, an adult may obtain a family licence from that council on payment of the appropriate fee specified in Part 3 of the Schedule.

## 8 Weekly licence

If a fish and game council issues weekly licences, an adult, a junior, or a young adult may obtain a weekly licence from that council on payment of the appropriate fee specified in Part 4 of the Schedule.

### 9 Whole-season licence

If a fish and game council issues whole-season licences,—

- (a) an adult, a junior, or a young adult may obtain a wholeseason licence from that council on payment of the appropriate fee specified in Part 5 of the Schedule:
- (b) a child may obtain a whole-season licence from that council without payment.

## 10 Winter licence

If a fish and game council issues winter licences, an adult, a junior, or a young adult may obtain a winter licence from that council on payment of the appropriate fee specified in Part 6 of the Schedule.

#### Forms

#### 11 Forms of licences

- (1) Every licence must be in writing and must specify—
  - (a) the holder's full name, postal address, telephone number (if any), and date of birth:
  - (b) the effect of the licence:
  - (c) the time and date of issue:
  - (d) the period during which the licence is valid:
  - (e) whether the holder is an adult, a child, a junior, or a young adult.
- (2) A family licence must specify, in addition to the matters referred to in subclause (1), the full names of the holder's family.

(3) An adult whole-season licence must specify, in addition to the matters referred to in subclause (1), whether the holder wishes to be an elector for the fish and game council.

## Revocation

### 12 Revocation

The Sports Fish Licences, Fees, and Forms Notice 2002 (SR 2002/235) is revoked.

## **Explanatory** note

This note is not part of the notice, but is intended to indicate its general effect.

This notice, which comes into force on 1 October 2003,—

- fixes the forms and classes of licences to fish for sports fish:
- fixes the scope and effect of those classes of licence:
- provides for the licences issued in respect of any region to be available in all other regions (except the Taupo District):
- fixes the fees payable for licences to fish for sports fish. These fees have been set to recover the anticipated costs of management of the freshwater sports fish resource by Fish and Game New Zealand for the 2003–04 season.
