THE SAMOA IMMIGRATION AMENDMENT ORDER 1941.

ORDER IN COUNCIL.

At the Government House at Wellington, this 22nd day of October, 1941.

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Samoa Act, 1921, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS.

1. This Order may be cited as the Samoa Immigration Amendment Order 1941.

2. This Order shall be read together with and form part of the Samoa Immigration Order 1930* (hereinafter called the principal Order), as amended by the Samoa Immigration Amendment Order 1935 and the Samoa Immigration Amendment Order 1938.[†]

3. This Order shall come into force on the 1st day of November, 1941.

4. Subclause (1) of clause 2 of the principal Order is revoked, and the following substituted :----

"(1) Save with the authority of the Administrator, no person shall land in Samoa from any place outside Samoa unless and until he shall have complied with the following requirements :---

- "(a) If he be over fourteen years of age, he shall have made and delivered to an officer of Customs or of police a declaration in the form set out in the First Schedule hereto; and
- "(b) Whether over fourteen years of age or not, unless he be a permanent resident of Samoa he shall have deposited with the Collector of Customs such sum or good and sufficient security to the satisfaction of the Collector for such sum not exceeding two hundred and fifty pounds, as the Administrator may deem necessary to defray the cost of transporting him to a place outside Samoa where he will be permitted to land, and any cost incurred by the Government or any public authority in his maintenance in Samoa including medical and hospital expenses :

"Provided, first, that in the calculation of what amount of deposit or security shall be deemed necessary as aforesaid regard may be had to the value of any ticket or other document which such person may deposit with the Collector of Customs entitling that person to a passage from Samoa:

"Provided, secondly, that if such person be at any time maintained in or by any Government or public institution the certificate of the Treasurer of Western Samoa shall be conclusive evidence of the cost of such maintenance."

5. Clause 12 of the principal Order is hereby amended by revoking paragraph (d) thereof, and substituting the following :—

"(d) Any person arriving in Samoa in the course of his journey to a place beyond Samoa as a paying passenger on board a ship of 100 tons or more not owned or controlled by him, if he leaves Samoa in that ship on her first departure from Samoa."
