



**THE STOCK IMPORTATION AMENDING REGULATIONS 1944**

**ORDER IN COUNCIL**

At the Government Buildings at Wellington, this 22nd day of  
November, 1944

Present :

**THE RIGHT HON. P. FRASER PRESIDING IN COUNCIL**

PURSUANT to the Stock Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

**REGULATIONS**

1. These regulations may be cited as the Stock Importation Amending Regulations 1944.

2. These regulations shall be read together with and form part of the regulations made under the Stock Act, 1908, on the 4th day of October, 1915, and published in the *Gazette* on the 7th day of the same month at page 3420 (hereinafter called the principal regulations).

3. These regulations shall come into force on the seventh day after notification in the *Gazette* of the making hereof.

4. The principal regulations, in so far as they relate to the introduction into the Dominion of dogs from the United Kingdom, are revoked, viz. :—

- (i) Regulations 12 and 13 thereof, and the heading “Dogs from the United Kingdom” next preceding Regulation 12 :
- (ii) The item in clause (1) of Regulation 40 thereof in the following words and figures :—  
“Dogs from the United Kingdom, 60 days” :
- (iii) Paragraph (c) of clause (2) of Regulation 40 thereof, as inserted by amending regulations made under the Stock Act, 1908, on the 24th day of September, 1934, and published in the *Gazette* on the 27th day of the same month at page 3000 :

(iv) The Sixth Schedule thereto :

(v) The items in the Fifteenth Schedule thereto (as replaced by Regulation 13 of the Stock Importation Amending Regulations 1939) in the following words and figures :—
