THE STOCK IMPORTATION AMENDING REGULATIONS 1945

ORDER IN COUNCIL

At the Government Buildings at Wellington, this 5th day of December, 1945

Present:

THE RIGHT HON. P. FRASER PRESIDING IN COUNCIL

Pursuant to the Stock Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

- 1. These regulations may be cited as the Stock Importation Amending Regulations 1945.
- 2. These regulations shall be read together with and form part of the regulations made under the Stock Act, 1908, on the 4th day of October, 1915, and published in the *Gazette* on the 7th day of the same month at page 3420 (hereinafter called the principal regulations).
- 3. These regulations shall come into force on the seventh day after notification in the *Gazette* of the making hereof.
- 4. The principal regulations are amended by inserting, next after Regulation 11A thereof (as inserted by Regulation 7 of the Stock Importation Amending Regulations 1939*), the following heading and regulations:—
 - "Dogs from the United Kingdom and Eire
- "12. (1) Subject to the provisions of these regulations, dogs may be introduced into the Dominion from the United Kingdom and Eire

- "(2) Every shipment of dogs to New Zealand must be accompanied by a statutory declaration in the form numbered 1 in the Sixth Schedule hereto, made by the shipper, setting forth the kind, number, colour, and sex of such dogs, and declaring that such dogs have been during the preceding nine months or from birth in the United Kingdom or Eire, that they are at the time of shipment, and have been during the preceding nine months, free from any infectious or contagious disease, and have not during the nine months immediately preceding shipment been in direct or indirect contact with any stock infected with any such disease.
- "(3) On every such declaration there shall be inscribed a certificate in the form numbered 2 in the Sixth Schedule hereto, signed by a veterinarian practising in the district in which such dogs have been domiciled during the six months immediately preceding the date of their shipment, or from which they start for the port of shipment, certifying that he has examined such dogs, and has found them free from any infectious or contagious disease.
- "13. The declaration and the certificate provided for in the last preceding regulation must be delivered to the veterinarian hereinafter required to examine at the port of shipment dogs intended for introduction into the Dominion, and no such certificate shall be valid if given more than fourteen days before the date of shipment."
- 5. Regulation 40 of the principal regulations, as heretofore amended, is further amended as follows:—
 - (a) By inserting in clause (1) thereof, next following the item "Swine from New South Wales, Victoria, South Australia, and Tasmania, 30 days", the item in the following words and figures—

"Dogs from the United Kingdom and Eire, 60 days".

(b) By inserting, next following paragraph (b) of clause (2) thereof,

the following paragraph—

- "(c) Dogs if found on arrival to be free from disease and not to be infected stock, and if the provisions of these regulations have been in all respects complied with, may be exempted from quarantine at a quarantine ground and a permit may be issued for them to be landed; subject, however, to their removal forthwith to the premises of the owner and being there held under the supervision of an Inspector and in segregation from other stock for a period of sixty days commencing from the date of the issue of a permit as aforesaid."
- 6. The principal regulations are further amended by inserting the following as the Sixth Schedule thereto:—

SHIPPER'S DECLARATION TO ACCOMPANY DOGS FROM THE UNITED KINGDOM OR EIRE TO NEW ZEALAND

I, [Full name and address of shipper], do solemnly and sincerely declare that the undermentioned dogs are, to the best of my knowledge and belief, free from any infectious or contagious disease; that they have been so during the nine months immediately preceding the date hereof; that they have not within the nine months immediately preceding the date hereof been in direct or indirect contact with stock infected with any such disease; and that they have been in this country for at least nine months immediately preceding the date hereof (or from birth).
