THE STOCK IMPORTATION AMENDING REGULATIONS 1951

THE RIGHT HON. S. G. HOLLAND PRESIDING IN COUNCIL

PURSUANT to the Stock Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Stock Importation Amending Regulations 1951, and shall be read together with and deemed part of the regulations made under the Stock Act, 1908, on the 4th day of October, 1915, and published in the *Gazette* on the 7th day of the same month at page 3420 (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day three months after the date of their notification in the *Gazette*.

2. Subclause (4) of regulation 8 of the principal regulations, as substituted by regulation 6 of the Stock Importation Amending Regulations 1947,* is hereby amended by omitting the words "the tuberculin test and the Johnin test with negative results", and substituting the words "the Mammalian tuberculin test and the Avian tuberculin test with negative results, that to the best of his knowledge and belief the cattle have not been in direct or indirect contact with any stock suffering from or infected with Johnne's disease and have not been at any time on any land where Johnne's disease is known to occur".

3. Paragraph (a) of subclause (4) of regulation 9 of the principal regulations, as substituted by regulation 6 of the Stock Importation Amending Regulations 1947,* is hereby amended by omitting the words "the tuberculin test and the Johnin test with negative results", and substituting the words "the Mammalian tuberculin test and the Avian tuberculin test with negative results, that to the best of his knowledge and belief the cattle have not been in direct or indirect contact with any stock suffering from or infected with Johnne's disease and have not been at any time on land where Johnne's disease is known to occur".

4. The Fourth Schedule to the principal regulations, as substituted by regulation 9 of the Stock Importation Amending Regulations 1947, hereby amended as follows :—

(a) By revoking paragraph (c) of form No. 2, and substituting the following paragraph :—

“(c) That within the period aforesaid—namely, on the day of, 19..—I applied the Mammalian tuberculin test and the Avian tuberculin test to the said cattle with negative results ;” :

(b) By inserting, after paragraph (d) of the said form No. 2, the following paragraph :—

“(e) That to the best of my knowledge and belief the said cattle have not been in direct or indirect contact with any stock suffering from or infected with Johnne’s disease and have not at any time been on land where Johnne’s disease is known to occur.” :

(c) By revoking paragraph (c) of form No. 4, and substituting the following paragraph :—

“(c) That within the period aforesaid—namely, on the day of, 19..—I applied the Mammalian tuberculin test and the Avian tuberculin test to the said cattle with negative results ;” :

(d) By inserting, after paragraph (d) of the said form No. 4, the following paragraph :—

“(e) That to the best of my knowledge and belief the said cattle have not been in direct or indirect contact with any stock suffering from or infected with Johnne’s disease and have not at any time been on land where Johnne’s disease is known to occur.”

EXPLANATORY NOTE

[*This note is not part of the regulations, but is intended to indicate their general effect.*]

These regulations relate to the importation of cattle from Great Britain and Canada. They require that the veterinarian’s certificate which has to be obtained under the existing regulations shall include a certificate that to the best of his knowledge and belief the cattle have not been in direct or indirect contact with any stock suffering from or infected with Johnne’s disease and have not been at any time on any land where Johnne’s disease is known to occur. They also require that the veterinarian’s certificate shall show that he has subjected the cattle to the Mammalian tuberculin test and the Avian tuberculin test instead of the tuberculin test and the Johnin test as required under the existing regulations.
