

THE STOCK IMPORTATION AMENDING REGULATIONS 1962

COBHAM, Governor-General ORDER IN COUNCIL

At the Government Buildings at Wellington this 12th day of February 1962

Pursuant to the Stock Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Stock Importation Amending Regulations 1962, and shall be read together with and deemed part of the regulations for the prevention of the introduction into New Zealand of diseases affecting stock made under the Stock Act 1908 on the 4th day of October 1915, and published in the Gazette on the 7th day of the same month at page 3420* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date

of their notification in the Gazette.

2. (1) The principal regulations are hereby amended by revoking

regulation 2, and substituting the following regulation:

- "2. (1) The introduction into New Zealand of any stock or animal manure, or of any fodder, litter, fittings, or other things which have, or which are reasonably believed by the Director-General of Agriculture to have, come into contact with any stock, is absolutely prohibited except where the introduction takes place in accordance with these regulations.
- "(2) Notwithstanding anything to the contrary in subclause (1) of this regulation, it shall be lawful for any person, with a prior permit in writing from the Director-General of Agriculture, and subject to such conditions as may be specified in the permit, to introduce into New Zealand meat which has been preserved or otherwise processed into any

meat product or any other portion of the carcass of any stock which has been manufactured into meat meal, bone meal, bone flour, or other food for stock or poultry.

"(3) Notwithstanding anything to the contrary in subclause (2) of this regulation, a permit shall not be required for the introduction into New Zealand, in sealed or airtight tins or other containers, of meat which has been preserved or otherwise processed into any meat product:

"Provided that nothing in this subclause shall apply to any meat or meat product which has been pasteurised or conveyed to New Zealand

under refrigeration."

- (2) Regulation 2 of the Stock Importation Amending Regulations 1953* is hereby consequentially revoked.
- 3. Regulation 3 of the principal regulations, as substituted by regulation 4 of the Stock Importation Amending Regulations 1947†, is hereby amended by inserting, after the words "United Kingdom", the words "the Channel Islands".
- 4. Subclause (4) of regulation 8 of the principal regulations, as substituted by regulation 6 of the Stock Importation Amending Regulations 1947† and amended by regulation 2 of the Stock Importation Amending Regulations 1951‡, is hereby further amended by revoking the words "the Mammalian tuberculin test and the Avian tuberculin test", and substituting the words "the intradermal mammalian tuberculin test and the intradermal avian tuberculin test".
- 5. (1) The principal regulations are hereby amended by revoking regulation 9 and the heading to that regulation, as substituted by regulation 6 of the Stock Importation Amending Regulations 1947; and substituting the following heading and regulation:

"CATTLE FROM THE UNITED KINGDOM, THE CHANNEL ISLANDS, AND EIRE

- "9. (1) Subject to the provisions of these regulations, cattle which are admitted to a quarantine station in the United Kingdom for animals intended for export controlled by the Ministry of Agriculture, Fisheries and Food in England, and are thereafter held in quarantine for a period of not less than 14 days, may be introduced into New Zealand from the United Kingdom, the Channel Islands, and Eire.
- "(2) Every person intending to introduce cattle as aforesaid shall first obtain a permit so to do from the Minister of Agriculture.
- "(3) Every shipment of such cattle shall be accompanied by a statutory declaration in the form No. 3 in the Fourth Schedule hereto, made by the owner of the cattle, setting forth the kind, number, sex, and brands or marks of the cattle, and declaring that the cattle have been continuously in the United Kingdom or the Channel Islands or Eire during the period of three months immediately preceding the date of removal to a quarantine station as aforesaid or from birth, that they are at the time of that removal and have been during the period aforesaid free from all infectious and contagious diseases, and that they have not during the period aforesaid been in direct or indirect contact with any stock suffering from or infected with any infectious or contagious disease.

- "(4) In addition to the statutory declaration prescribed by subclause (3) of this regulation, every shipment of such cattle shall be accompanied by:
 - "(a) A certificate in the form No. 4 in the Fourth Schedule hereto, signed by a veterinarian employed or approved for the purpose by the Ministry of Agriculture, Fisheries and Food in England, or the Ministry of Agriculture, Northern Ireland, or the Department of Agriculture, Eire, and certifying that he has within the period of 30 days immediately preceding the date of their removal to a quarantine station examined the cattle and has found them free from infectious and contagious diseases, that within the period aforesaid he has on a day, the date of which is to be stated in the certificate, subjected the cattle to the intradermal mammalian tuberculin test and the intradermal avian tuberculin test and the complementfixation test for Johne's disease, with negative results, that to the best of his knowledge and belief the cattle have not been in direct or indirect contact with any stock suffering from or infected with Johne's disease and have not been at any time on any land where Johne's disease is known to occur, and that within the period aforesaid he has on a day, the date of which is to be stated in the certificate, subjected the cattle to the agglutination test for Brucellosis with negative results or that he is satisfied after due inquiry that the cattle have been vaccinated against Brucellosis; and
 - "(b) A certificate in the form No. 5 in the Fourth Schedule hereto, signed by a veterinarian employed by the Ministry of Agriculture, Fisheries and Food in England and certifying that the cattle have been detained and isolated in a quarantine station under the control of that Ministry for a period of not less than 14 days immediately preceding the date of shipment, that during the period aforesaid they have remained free from all infectious and contagious diseases, that all fodder and litter supplied for the use of the cattle during the voyage have been obtained from districts which have been free from foot and mouth disease during the period of six months immediately preceding the date of shipment of the cattle, and that all such fodder and litter have not during the period aforesaid been exposed to infection or contamination.
- "(5) The provisions of regulation 19 of these regulations shall not apply to cattle authorised to be introduced into New Zealand in accordance with the foregoing provisions of this regulation."
 - (2) The following regulations are hereby revoked:
 - (a) Regulation 3 of the Stock Importation Amending Regulations 1951:*
 - (b) Regulation 3 of the Stock Importation Amending Regulations 1953†:

- 6. Regulation 10 of the principal regulations and the heading to that regulation, as substituted by regulation 6 of the Stock Importation Amending Regulations 1947,* are hereby amended as follows:
 - (a) By omitting the words "Great Britain", wherever those words occur, and substituting the words "the United Kingdom":(b) By omitting the words "Agriculture and Fisheries", wherever
 - (b) By omitting the words "Agriculture and Fisheries", wherever those words occur, and substituting the words "Agriculture, Fisheries and Food".
- 7. Regulation 11 of the principal regulations and the heading to that regulation, as substituted by regulation 6 of the Stock Importation Amending Regulations 1947,* are hereby amended as follows:
 - (a) By omitting the words "Great Britain", wherever those words occur, and substituting the words "the United Kingdom":
 - (b) By omitting the words "Agriculture and Fisheries", wherever those words occur, and substituting the words "Agriculture, Fisheries and Food".
- 8. Regulation 13 of the principal regulations, as inserted by regulation 4 of the Stock Importation Amending Regulations 1945†, is hereby amended by omitting the word "fourteen", and substituting the word "twenty-one".
- 9. (1) The principal regulations are hereby further amended by inserting after regulation 13, as inserted by regulation 4 of the Stock Importation Amending Regulations 1945†, the following regulation:
- "13a. Every shipment of dogs to New Zealand shall be accompanied by a certificate in the form No. 3 in the Sixth Schedule hereto, signed by a veterinarian practising in the district in which the dogs have been domiciled during the six months immediately preceding the date of their shipment, or from which they start for the port of shipment, certifying that within the period of 21 days immediately preceding the date of their shipment he administered to the dogs are coline hydrobromide or are coline acetarsol in sufficient quantity or ally to cause them to purge and that, from examination of the purged material, he was satisfied that the same was free from tapeworms, including those of the genus Echinococcus."
- (2) This regulation shall apply to dogs introduced into New Zealand on and after the date of the commencement of these regulations.
- 10. (1) Regulation 32 of the principal regulations is hereby amended by adding the following subclause:
- "(4) Every shipment of dogs to New Zealand shall be accompanied by a certificate in the form No. 7 in the Fourteenth Schedule hereto, signed by a veterinarian practising in the district in which the dogs have been domiciled during the six months immediately preceding the date of their shipment, or from which they start for the port of shipment, and certifying that within the period of 21 days immediately preceding the date of their shipment he administered to the dogs are coline hydrobromide or are coline acetarsol in sufficient quantity or ally to cause them to purge and that, from examination of the purged material, he was satisfied that the same was free from tapeworms, including those of the genus Echinococcus."

- (2) This regulation shall apply to dogs introduced into New Zealand on and after the date of the commencement of these regulations.
- 11. (1) Regulation 40 of the principal regulations, as substituted by regulation 7 of the Stock Importation Amending Regulations 1947,* is hereby amended as follows:
 - (a) By omitting from subclause (1) the words "Great Britain", wherever those words occur, and substituting the words "the United Kingdom, the Channel Islands, Eire,":
 - (b) By omitting from subclause (1) the words "Dogs from the United Kingdom, the Channel Islands, and Eire, 60 days".
- (2) Regulation 40 of the principal regulations is hereby further amended as follows:
 - (a) By revoking paragraph (a) of subclause (2):
 - (b) By revoking subclause (3).
- (3) Regulation 5 of the Stock Importation Amending Regulations 1945† is hereby revoked.
- (4) Regulation 5 of the Stock Importation Amending Regulations 1953‡ is hereby consequentially amended by revoking paragraphs (a) and (d).
- 12. (1) The Fourth Schedule to the principal regulations, as substituted by regulation 9 of the Stock Importation Amending Regulations 1947* and heretofore amended, is hereby further amended as follows:
 - (a) By omitting from paragraph (c) of form No. 2 the words "the Mammalian tuberculin test and the Avian tuberculin test", and substituting the words "the intradermal mammalian tuberculin test and the intradermal avian tuberculin test":
 - (b) By omitting the words "Great Britain or the Channel Islands", wherever they occur in forms Nos. 3 and 5, and substituting in each case the words "the United Kingdom, the Channel Islands, and Eire":
 - (c) By omitting the words "Agriculture and Fisheries", wherever those words occur in forms Nos. 3 and 5, and substituting in each case the words "Agriculture, Fisheries and Food":
 - (d) By revoking form No. 4, and substituting the form No. 4 set out in the First Schedule hereto.
 - (2) The following regulations are hereby consequentially revoked:
 - (a) Paragraph (c) of regulation 4 of the Stock Importation Amending Regulations 1951§:
 - (b) Regulation 3 of the Stock Importation Amending Regulations 1955||.
- 13. The Fifth Schedule to the principal regulations, as substituted by regulation 10 of the Stock Importation Amending Regulations 1947,* is hereby amended as follows:
 - (a) By omitting the words "Great Britain", wherever those words occur, and substituting the words "the United Kingdom":
 - (b) By omitting the words "Agriculture and Fisheries", wherever those words occur, and substituting the words "Agriculture, Fisheries and Food".

- 14. The Sixth Schedule to the principal regulations, as inserted by regulation 6 of the Stock Importation Amending Regulations 1945* and amended by regulation 8 of the Stock Importation Amending Regulations 1953†, is hereby further amended by adding the form No. 3 set out in the Second Schedule hereto.
- 15. The Fourteenth Schedule to the principal regulations, as amended by regulation 4 of the regulations made under the Stock Act 1908 on the 22nd day of July 1936 and published in the Gazette on the 23rd day of the same month at page 1389 and by regulation 7 of the Stock Importation Amending Regulations 1941‡, is hereby further amended by adding the form No. 7 set out in the Third Schedule hereto.

16. (1) Regulation 2 of the Stock Importation Amending Regulations 1954§ is hereby amended by omitting from subclause (1) the words "Great Britain", and substituting the words "the United Kingdom".

- (2) Regulation 3 of the Stock Importation Amending Regulations 1954§ is hereby amended by omitting the words "Agriculture and Fisheries", wherever those words occur, and substituting in each case the words "Agriculture, Fisheries and Food".
 - (3) The Schedule to the Stock Importation Amending Regulations

1954§ is hereby amended as follows:

- (a) By omitting the words "Great Britain", wherever those words occur, and substituting in each case the words "the United Kingdom":
- (b) By omitting the words "Agriculture and Fisheries" wherever those words occur in forms Nos. 2 and 3, and substituting in each case the words "Agriculture, Fisheries and Food".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations vary the requirements governing the importation into New Zealand of horses, dogs, and cattle from the United Kingdom, the Channel Islands, and Eire; sheep, goats, and swine from the United Kingdom; cattle from Canada; dogs from Australia; and wool from the United Kingdom; and the requirements governing the quarantine of livestock introduced into New Zealand.

Issued under the authority of the Regulations Act 1936. Date of notification in *Gazette*: 15 February 1962. These regulations are administered in the Department of Agriculture.
