**THE STOCK IMPORTATION AMENDING REGULATIONS
(NO. 2) 1962**

ORDER IN COUNCIL

At the Government Buildings at Wellington this 21st day of May 1962

THE HON. J. R. HANAN PRESIDING IN COUNCIL

PURSUANT to the Stock Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Stock Importation Amending Regulations (No. 2) 1962, and shall be read together with and deemed part of the regulations for the prevention of the introduction into New Zealand of diseases affecting stock made under the Stock Act 1908 on the 4th day of October 1915, and published in the *Gazette* on the 7th day of the same month at page 3420* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.

2. (1) The principal regulations shall extend and apply to every horse, sheep, goat, and dog carried on any aircraft from Australia to New Zealand as if the animal were carried on a vessel or ship from Australia to New Zealand.

(2) For the purposes of subclause (1) of this regulation—

- (a) The principal regulations shall extend and apply to aircraft as they apply to vessels and ships, and to airports as they apply to ports;
- (b) Any reference in the principal regulations to a vessel trading shall be read as a reference to an aircraft operating.

3. Regulation 31 of the principal regulations, as amended by regulation 8 of the Stock Importation Amending Regulations 1939, is hereby further amended by adding the following additional proviso:

“Provided also that horses, sheep, goats, and dogs may be landed at the airports at Whenuapai, Ohakea, Paraparaumu, Rongotai, and Harewood.”

4. Regulation 32 of the principal regulations is hereby further amended by inserting in subclause (3), after the word “cleansed”, the words “and disinfected”.

5. Regulation 32A of the principal regulations, which was inserted by regulation 3 of the amending regulations for the prevention of the introduction into New Zealand of diseases affecting stock made under the Stock Act 1908 on the 22nd day of July 1936 and published in the *Gazette* on the 23rd day of the same month at page 1389, is hereby amended by inserting in subclause (3), after the words “at any time”, the words “during the six months immediately preceding shipment”.

6. The principal regulations are hereby amended by inserting, after regulation 34, the following regulation:

“34A. The provisions of regulation 34 of these regulations shall, with the necessary modifications, apply to any aircraft arriving in New Zealand and to any horses, sheep, goats, or dogs conveyed in the aircraft.”

7. Regulation 36 of the principal regulations is hereby amended by adding, as subclause (2), the following subclause:

“(2) The provisions of this regulation shall, with the necessary modifications, apply to any aircraft arriving in New Zealand and to any horses, sheep, goats, or dogs conveyed in the aircraft.”

8. Regulation 70 of the principal regulations is hereby amended by omitting the words “the waters of”.

9. Regulation 72 of the principal regulations is hereby amended by inserting, after the words “by sea”, the words “or by air”.

10. The Fourteenth Schedule to the principal regulations is hereby amended by inserting, after the words “at any time” in clause 3 of Form No. 3, which form was inserted by regulation 4 of the amending regulations for the prevention of the introduction into New Zealand of diseases affecting stock made under the Stock Act 1908 on the 22nd day of July 1936 and published in the *Gazette* on the 23rd day of the same month at page 1389, the words “during the six months immediately preceding shipment”.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations provide for the introduction into New Zealand by air of horses, sheep, goats, and dogs from Australia.

Issued under the authority of the Regulations Act 1936.

Date of notification in *Gazette*: 24 May 1962.

These regulations are administered in the Department of Agriculture.
