

THE SOUTHERN LAKES FISHING REGULATIONS 1951, AMENDMENT NO. 3

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. (1) These regulations may be cited as the Southern Lakes Fishing Regulations 1951, Amendment No. 3, and shall be read together with and deemed part of the Southern Lakes Fishing Regulations 1951* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. (1) Regulation 2 of the principal regulations is hereby amended by revoking the definition of the term "open season" in subclause (1), and substituting the following definition:
 - "'Open season' means-
 - "(a) In respect of all rivers and streams flowing into Lake Hawea or Lake Wanaka and the tributaries of those rivers and streams, the 1st day of November in any year to the 30th day of April in the year next following (both days inclusive):

"(b) In respect of the Upukerora River, the 1st day of October in any year to the last day of February in the year next following (both days inclusive):

"(c) In respect of all other waters in the district, the 1st day of October in any year to the 30th day of Ápril in the year next following (both days inclusive):".

- (2) Regulation 15 of the principal regulations is hereby amended by omitting the words "and shall expire on the 30th day of April next following the date of issue thereof", and substituting the words "and in respect of the Upukerora River shall expire on the last day of February next following the date of issue thereof, and in respect of all other waters in the district shall expire on the 30th day of April next following the date of issue thereof".
- 3. The principal regulations are hereby amended by revoking regulation 29, and substituting the following regulation:
- "29. No person shall in any one day take in the district more than six acclimatized fish, being trout or Atlantic salmon, or more than four Atlantic salmon, and no person shall continue to fish for any such acclimatized fish in the district on any day on which he has already taken six such acclimatized fish:

"Provided that the numbers hereby specified shall be exclusive of acclimatized fish dealt with pursuant to regulation 31 of these regulations."

4. Regulation 33 of the principal regulations is hereby amended by

adding to subclause (2) the following paragraph:

- "(e) That portion of the Clutha River lying between a point indicated by a landmark, approximately 600 yards from the outlet of Lake Wanaka, and a point indicated by a landmark, approximately 600 yards above the bridge at Albert Town."
- 5. (1) Regulation 34 of the principal regulations is hereby amended by revoking paragraph (c) of subclause (2).
- (2) Regulation 34 of the principal regulations is hereby further amended by inserting in paragraph (d) of subclause (2), after the word "Diamond", the word "Dispute".

EXPLANATORY NOTE

[This note is not part of the regulations, but is intended to indicate their general effect.]

These regulations make miscellaneous amendments to the Southern Lakes Fishing Regulations 1951.

Regulation 2 substitutes a new definition of the term "open season", which

in future will vary in different parts of the district.

Regulation 3 reduces from ten to six the limit bag for acclimatized fish, being trout or Atlantic salmon, of which not more than four may be Atlantic salmon. Quinnat salmon are not to be counted in the limit bag.

Regulation 4 imposes certain restrictions on methods of fishing in part of

the Clutha River.

The effect of regulation 5 is to permit trolling in the Waiau River and its tributaries and to prohibit trolling in Lake Dispute.
