

THE SOUTHERN LAKES FISHING REGULATIONS 1951, AMENDMENT NO. 6

Pursuant to the Fisheries Act 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. (1) These regulations may be cited as the Southern Lakes Fishing Regulations 1951, Amendment No. 6, and shall be read together with and deemed part of the Southern Lakes Fishing Regulations 1951* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date

of their notification in the *Gazette*.

2. (1) Regulation 2 of the principal regulations is hereby amended by inserting in the definition of the term "acclimatised fish" in subclause (1), before the words "and perch", the words "the American brook trout (Salvelinus fontinalis)".

(2) Regulation 2 of the principal regulations is hereby further amended by revoking the definition of the term "open season" in subclause (1) (as substituted by regulation 2 (1) of the Southern Lakes Fishing Regulations 1951, Amendment No. 3), and substituting the following definition:

"'Öpen season' means—

"(a) In respect of all rivers and streams flowing into Lake Hawea and Lake Wanaka and the tributaries of those rivers and streams (except Bullock Creek which flows into Lake Wanaka), the 1st day of December in any year to the 30th day of April in the year next following (both days inclusive):

"(b) In respect of the Upukerora River, the 1st day of October in any year to the last day of February in the year next following (both days inclusive):

"(c) In respect of all other waters in the district, except those described in regulation 35 hereof, the 1st day of October in any year to the 30th day of April in the year next following (both days inclusive):".

- (3) Regulation 2 of the Southern Lakes Fishing Regulations 1951, Amendment No. 3, is hereby amended by revoking subclause (1).
- 3. Regulation 27 of the principal regulations is hereby amended by inserting in paragraph (e), after the words "one hook", the words "or a multiple hook".
- 4. Regulation 33 of the principal regulations (as amended by regulation 4 of the Southern Lakes Fishing Regulations 1951, Amendment No. 3) is hereby further amended by adding to subclause (2) the following paragraph:

"(f) The Nevis River."

5. The principal regulations are hereby amended by revoking regu-

lation 35, and substituting the following regulation:

"35. Nothing in these regulations or in any licence issued under these regulations shall be deemed to authorise any person to fish for, take, or kill acclimatised fish in or from-

"(a) Queenstown Bay, Lake Wakatipu, inside a straight line drawn from the outermost point of the Tourist Park to the point where the south bank of One Mile Creek meets Lake Wakatipu:

"(b) That portion of the Waiau River which is within 50 yards of any part of the wharf belonging to the Sea Prince Lake Service Company Limited on the Waiau River, Lake Manapouri."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

The effect of regulation 2 (1) is to declare American brook trout to be acclimatised fish for the purposes of the regulations.

The effect of regulation 2 (2) is that the open season in rivers and streams flowing into Lakes Hawea and Wanaka and their tributaries (except Bullock Creek) will commence on 1 December instead of on 1 November.

The effect of regulation 3 is to prohibit the use of a multiple hook with any

form of spoonbait.

The effect of regulation 4 is to permit only fly fishing in the Nevis River. Regulation 5 contains a new description of the waters in the district in which fishing is prohibited at all times.
