**THE SHIPPING (RECOGNITION OF CERTIFICATES OF
COMPETENCY) ORDER 1965**

ORDER IN COUNCIL

At the Government House at Wellington this 19th day of May 1965

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Shipping and Seamen Act 1952, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

O R D E R

1. This order may be cited as the Shipping (Recognition of Certificates of Competency) Order 1965.

2. It is hereby declared that certificates of competency of kinds or grades corresponding to those specified in the second column of the Schedule to this order granted by or under the authority of the governments of the countries specified in the first column of that Schedule shall be of the same force and effect as if they were certificates of the corresponding kind or grade granted pursuant to the Shipping and Seamen Act 1952, and shall have effect as if they have so been granted.

3. (1) The Orders in Council made under the Merchant Shipping Act 1894 of the United Kingdom Parliament, or continuing in force as if they had been made under that Act, specified in Appendix G to the Masters and Mates (Foreign Going and Unrestricted Home Trade) Examination Regulations 1961* shall as from the commencement of this order cease to have effect as part of the law of New Zealand.

(2) The Masters and Mates (Foreign Going and Unrestricted Home Trade) Regulations 1961* are hereby amended—

(a) By revoking the proviso to the definition of the term “certificate” in regulation 2 (1):

(b) By revoking Appendix G.

(3) Regulation 2 of the Marine Engineers Examination Regulations 1961† is hereby amended by revoking the proviso to the definition of the term “certificate”.

(4) Every certificate of competency granted before the commencement of this order by or under the authority of the Government of any country other than New Zealand and having immediately before

the commencement of this order the same force as if it had been granted under the Shipping and Seamen Act 1952 shall after the commencement of this order continue in force and have effect as if this order had not been made.
