



**THE SHIPPING (RECOGNITION OF CERTIFICATES OF
COMPETENCY) ORDER 1988, AMENDMENT NO. 1**

PURSUANT to section 18 of the Shipping and Seamen Act 1952, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

ORDER

1. Title and commencement—(1) This order may be cited as the Shipping (Recognition of Certificates of Competency) Order 1988, Amendment No. 1, and shall be read together with and deemed part of the Shipping (Recognition of Certificates of Competency) Order 1988* (hereinafter referred to as the principal order).

(2) This order shall come into force on the 28th day after the date of its notification in the *Gazette*.

2. Australian Uniform Shipping Laws Code certificates—The principal order is hereby amended by inserting, after clause 3, the following clause:

“3A. It is hereby declared that the certificates specified in the first column of the Third Schedule to this order granted under the authority of the Government of the Commonwealth of Australia, being certificates

granted under the Australian Uniform Shipping Laws Code 1991, shall be of the same force and effect as if they were certificates granted under the Shipping and Seamen Act 1952 of the respective kinds specified in the second column of that Schedule, and shall have effect as if they were so granted.”

3. New Third Schedule added—The principal order is hereby amended by adding the Third Schedule set out in the Schedule to this order.

EXPLANATORY NOTE

This note is not part of the order, but is intended to indicate its general effect.

This order, which comes into force 28 days after the date of its notification in the *Gazette*, amends the Shipping (Recognition of Certificates of Competency) Order 1988.

The purpose of the order is to recognise certain Australian maritime certificates as being equivalent to the corresponding New Zealand certificates. The Australian certificates and the corresponding New Zealand certificates are set out in the new *Third Schedule* set out in the Schedule to this order.
