# THE SALE OF FRUIT AND VEGETABLE CONTAINERS EMERGENCY REGULATIONS 1945

### C. L. N. NEWALL, Governor-General ORDER IN COUNCIL

At the Government Buildings at Wellington, this 24th day of January, 1945

#### Present:

THE RIGHT HON. P. FRASER PRESIDING IN COUNCIL

Pursuant to the Emergency Regulations Act, 1939, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

#### REGULATIONS

- 1. These regulations may be cited as the Sale of Fruit and Vegetable Containers Emergency Regulations 1945, and shall come into force on the 1st day of February, 1945.
- 2. (1) For the purposes of these regulations, the expression "f.a.q." when used with respect to fruit-cases, refers to fruit-cases that, at the time of sale, are fit for further use as containers of fruit for sale, and, when used with respect to any other cases, or to sacks or bags, refers to cases, sacks, or bags that, at the time of sale, are fit for further use as containers of vegetables for sale.
- (2) If any question arises as to whether or not any cases, sacks, or bags are "f.a.q." within the meaning of these regulations, it may be referred to any Inspector appointed under the Orchard and Garden Diseases Act, 1928, and in any such case the decision of the Inspector shall be final.

# CHARGES BY VENDORS FOR F.A.Q. CONTAINERS OF FRUIT AND VEGETABLES

- 3. (1) No vendor shall be entitled to make any charge in respect of the cases or sacks in which potatoes or onions are sold or offered for sale.
- (2) Except as provided in the last preceding subclause, every person who sells by way of wholesale any fruit or vegetables shall charge for the container the appropriate charge (if any) specified in the Schedule hereto.

- (3) Except as provided in subclause (1) hereof, or except as may be provided in any Price Order made by the Price Tribunal under the Control of Prices Emergency Regulations 1939,\* any person who sells by way of retail any fruit or vegetables may make in respect of the container a charge not exceeding the appropriate charge (if any) specified in the Schedule hereto.
- 4. If any retailer buys from any person (other than a wholesaler) any used fruit or vegetable containers of a kind specified in the Schedule hereto, he shall pay therefor the appropriate price specified in that Schedule, less 1d. for each such container.
