

# THE SALE OF HONEY (EXPORT CONTROL) REGULATIONS 1971

### ORDER IN COUNCIL

At the Government Buildings at Wellington this 26th day of January 1971

Pursuant to the Primary Products Marketing Act 1953, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. Title—These regulations may be cited as the Sale of Honey (Export Control) Regulations 1971.
- 2. Interpretation—(1) In these regulations, unless the context otherwise requires,—
  - "Sale" includes any offer to sell, offer to purchase, conditional offer, and invitation to treat, whether or not completed, or capable of completion, by acceptance.
- (2) These regulations shall apply to any sale of more than 10 lb of honey, and to any sale of less than 10 lb of honey if that sale, together with any other sale or sales made between the same vendor and purchaser, relate to a total of more than 10 lb of honey; but shall not apply to any sale of honey for the purpose of exporting from New Zealand by way of gift to any single recipient not more than 10 lb of honey.
  - 3. Sales of honey for export—No person shall—
  - (a) Sell any honey for export from New Zealand; or
- (b) Sell any honey which has been exported from New Zealand,—unless the prior consent of the Minister of Agriculture, or of such person as he may appoint in that behalf, has been obtained to the export of the honey from New Zealand, and compliance has been made with all terms and conditions subject to which that consent has been given.

4. Offences—(1) Every person commits an offence against these regulations who acts in contravention of or fails to comply in any

respect with any provision of these regulations.

(2) Every person who commits an offence against these regulations shall be liable on summary conviction to a fine not exceeding \$400, in the case of an individual, and, in the case of a body corporate, to a fine not exceeding \$2,000.

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations require the prior consent of the Minister of Agriculture or of such other person as he may appoint to be given to any sale of more than 10 lb of honey for export from New Zealand or which has been exported from New Zealand. The regulations apply to any sale of less than 10 lb of honey if that sale, together with any other sale or sales made between the same vendor and purchaser relate to a total of more than 10 lb of honey, but do not apply to any sale of honey for the purpose of exporting from New Zealand by way of gift to any single recipient not more than 10 lb of honey.
