**ORDER IN COUNCIL**

At Wellington this 2nd day of October 1989

Present:

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL

PURSUANT to sections 286 and 299 of the Sale of Liquor Act 1962, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

**REGULATIONS**

**1. Title and commencement**—(1) These regulations may be cited as the Sale of Liquor Regulations 1963, Amendment No. 13, and shall be read together with and deemed part of the Sale of Liquor Regulations 1963\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 5th day of October 1989.

**2. Fees**—(1) The Second Schedule to the principal regulations (as substituted by regulation 2 (1) of the Sale of Liquor Regulations 1963, Amendment No. 12) is hereby amended by revoking clause 6, and substituting the following clause:

“6. For every grant of a club charter under section 164 of the Act, and every renewal of such a charter, there shall be paid to the Secretary of the Commission a fee of .. .. .	600
“For every permanent club charter under section 175 of the Act, there shall be paid to the Secretary of the Commission an annual fee of .. .. .	600.”

(2) Clause 15 of the Second Schedule to the principal regulations (as so substituted) is hereby amended by inserting, after the item relating to extended hotelkeepers’ licences, the following item:

“For every tavernkeeper’s licence and every renewal of such a licence .. .. .	360.”

(3) Clause 15 of the Second Schedule to the principal regulations (as so substituted) is hereby further amended by omitting the expression “1,800”, and substituting the expression “1,440”.

(4) The Second Schedule to the principal regulations (as so substituted) is hereby further amended by inserting, after clause 17, the following clause:

“17A. For every airport licence, and every renewal of such a licence, there shall be paid under section 286(2c) of the Act to the Secretary of the Commission a fee of .. .. .	360.”

(5) The Second Schedule to the principal regulations is hereby further amended by revoking clause 19.

EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force on 5 October 1989, alter certain fees payable under the Sale of Liquor Act 1962, consequential upon the closing of the Licensing Fund by the Licensing Fund Act 1989 and the various provisions made by the Sale of Liquor Amendment Act 1989.
