

THE SALE OF LIQUOR REGULATIONS 1963, AMENDMENT NO. 6

THE RIGHT HON. R. D. MULDOON PRESIDING IN COUNCIL

PURSUANT to the Sale of Liquor Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Sale of Liquor Regulations 1963, Amendment No. 6, and shall be read together with and deemed part of the Sale of Liquor Regulations 1963* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date

of their notification in the Gazette.

- 2. Functions of viticulturist—The principal regulations are hereby amended—
 - (a) By omitting from the definition of the term "viticulturist" in regulation 2 the words "Department of Agriculture", and substituting the words "Ministry of Agriculture and Fisheries":
 - (b) By omitting from regulation 10 (4) the words "and a copy to the Viticulturist at Auckland":

(c) By revoking regulations 10 (6), 12 (3), and 13 (2) (c):

(d) By omitting from regulation 15 (1) the words "or any Viticulturist":

(e) By revoking regulation 15 (2):

- (f) By omitting from regulation 18 (2) the words ", and a copy to the Viticulturist at Auckland":
- (g) By revoking regulation 18 (4).

Notice of grants and renewals to be given to viticulturist—The principal regulations are hereby amended by inserting, after regulation 15, the following regulation:

"15A. Where any wine maker's licence is granted or renewed under

the Act, the Clerk shall notify the Viticulturist."

4. Increase in quantity authorised by wine maker's licence—(1) Regulation 14 of the principal regulations is hereby revoked.

(2) Form 39 in the First Schedule to the principal regulations is

hereby consequentially revoked.

5. Application for grant or renewal of manager's certificate—(1) The First Schedule to the principal regulations is hereby amended by revoking form 48, and substituting the form numbered 48 set out in the Schedule to these regulations.

(2) The said First Schedule is hereby further amended by revoking form 49, and substituting the form numbered 49 set out in the Schedule

to these regulations.

6. Permit for social gathering on premises in respect of which general ancillary licence is in force—(1) The principal regulations are hereby amended by inserting, after regulation 30B (as inserted by regulation 3 of the Sale of Liquor Regulations 1963, Amendment No. 5), the following regulation:

"30c. (1) Every application for a permit under section 218в of the Act shall be in form 56g, and every such permit shall be in form 56н.

"(2) Every such application shall have endorsed thereon the signed consent of the holder of the general ancillary licence in respect of the premises on which it is proposed to hold the gathering to which the application relates, or of any person authorised by the holder of that licence to consent on the holder's behalf.

"(3) The provisions of regulation 30 of these regulations, so far as they are applicable and with the necessary modifications, shall apply with respect to applications for and the grant of permits under section

218_B of the Act."

- (2) The First Schedule to the principal regulations is hereby amended by inserting, after form 56F (as inserted by regulation 7 of the Sale of Liquor Regulations 1963, Amendment No. 5), the forms numbered 56G and 56H set out in the Schedule to these regulations.
- 7. Amendments of prescribed forms—(1) Form 16 in the First Schedule to the principal regulations is hereby amended—

(a) By omitting the expression "9 litres" (as substituted by regulation 6 (7) (a) of the Sale of Liquor Regulations 1963, Amendment No. 5), and substituting the expression "8 litres":

(b) By omitting the expression "one reputed quart", and substituting the expression "760 millilitres".

(2) Form 17 in the said First Schedule is hereby amended by omitting the word "kegs", and substituting the word "containers".

(3) Form 21 in the said First Schedule is hereby amended by omitting

1963, Amendment No. 5), and substituting the words "the latest hour authorised for a gathering of the type proposed on that day by subsection (1) or (as the case may require) subsection (1c) of section 69 of the Act, and not being more than the total number of hours authorised for that day by subsection (1A) of that section".

(4) Form 32 in the said First Schedule is hereby amended—

(a) By omitting the words "I hereby declare":

(b) By revoking paragraphs (1) and (2).

(5) Form 33 in the said First Schedule is hereby amended by revoking

the second paragraph.

(6) Form 34 in the said First Schedule (as amended by regulation 6 (14) (a) of the Sale of Liquor Regulations 1963, Amendment No. 5) is hereby amended by omitting the words "a total quantity not exceeding litres of".

(7) Form 35 in the said First Schedule (as amended by regulation 6 (15) (a) of the Sale of Liquor Regulations 1963, Amendment No. 5) is hereby amended by omitting the words "a total quantity not exceeding litres of".

(8) Form 54 in the said First Schedule is hereby amended by

revoking paragraph (a).

(9) Regulation 6 of the Sale of Liquor Regulations 1963, Amendment No. 5 is hereby consequentially amended by revoking subclauses (7) (a), (9) (b), (12), (13), (14) (a), and (15) (a).

 This permit is issued subject to the following conditions: (a) That no charge shall be made to any person for liquor supplied under this permit other than a charge, or charges, payable for admission to the gathering: (b) That, except in the case of employees or other persons engaged in service at the gathering, no persons shall be admitted to the gathering except the person or persons holding or promoting the gathering and guests specially invited thereto: (c) That liquor shall not be supplied or consumed after the hour last mentioned in this permit: (d) Where the gathering is for the purposes of a dance, that the only liquor consumed at the dance shall be liquor supplied pursuant to the permit and that no liquor shall be taken into the premises by any guest or other person while the dance is being held.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the Sale of Liquor Regulations 1963, consequent upon a number of amendments effected by the Sale of Liquor Amendment Act 1977.

Regulation 1 relates to the Title and commencement.

Regulation 2: Under the principal regulations, copies of applications for wine makers' licences, and for the renewal of such licences, are to be forwarded to the Viticulturist, who is an officer of the Ministry of Agriculture and Fisheries. He is entitled to submit a report in respect of every such application. This requirement is now dropped, and this regulation provides accordingly.

Regulation 3 requires notice of the grant and renewal of wine makers' licences to be given to the Viticulturist.

Regulation 4 revokes regulation 14 of the principal regulations, relating to the quantity of wine to be manufactured pursuant to a wine maker's licence. No limit is now imposed on the amount that may be so manufactured.

Regulation 5 prescribes a new form for managers' certificates, recognising the 3 different types of certificate now provided for by the Act.

Regulation 6 prescribes the form of application for a permit for a social gathering on premises in respect of which a general ancillary licence is in force. It also prescribes the form of the permit.

Regulation 7 amends a number of prescribed forms set out in the First Schedule to the principal regulations.
