ORDER IN COUNCIL

At the Government Buildings at Wellington this 22nd day of March 1982

PURSUANT to section 299 of the Sale of Liquor Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Sale of Liquor Regulations 1963, Amendment No. 9, and shall be read together with and deemed part of the Sale of Liquor Regulations 1963* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 1st day of April 1982.

2. Interpretation—(1) Regulation 2 of the principal regulations is

hereby amended by omitting the definition of the term "viticulturist".

(2) Regulation 2 (a) of the Sale of Liquor Regulations 1963, Amendment No. 6 is hereby consequentially revoked.

3. Application for renewal of licence—(1) Regulation 8 (1) of the principal regulations is hereby amended by omitting from subsection (1) the words "(other than the holder of a wine maker's licence)".

(2) Regulation 8 (2) of the principal regulations is hereby amended by

omitting the words "(other than a wine maker's licence)".

(3) Regulation 8 (3) of the principal regulations is hereby revoked.

4. Wine makers' licences—(1) The principal regulations are hereby amended by revoking the heading before regulation 10, and by revoking regulations 10 to 16.

(2) Paragraphs (b) to (e) of regulation 2, and regulations 3 and 4, of the Sale of Liquor Regulations 1963, Amendment No. 6 are hereby

consequentially revoked.

5. New heading and regulations inserted in principal regulations—The principal regulations are hereby amended by inserting, after regulation 18, the following heading and regulations:

"Alcoholic Drinks Licence

- "18A. Application for grant, renewal, transfer, or removal of alcoholic drinks licence—(1) Every application for an alcoholic drinks licence shall be in form 44A.
- "(2) Every application for the renewal of an alcoholic drinks licence shall be in form 44c.
- "(3) Every application for the transfer of an alcoholic drinks licence shall be in form 44D.
- "(4) Every application for the removal of an alcoholic drinks licence shall be in form 44E.
- "18B. Commission or Chairman may require further information—On any application for the grant, renewal, transfer, or removal of an alcoholic drinks licence, the Commission or, as the case may be, the Chairman of the Commission or the Chairman of the Licensing Committee may require the applicant to supply such further information as the Commission or the Chairman may reasonably consider to be

necessary to enable it or him to be satisfied of the matters specified in section 161F(2) or section 161F(3) or section 161I(4) or section 161J(5) or section 161K(7) or section 161K(8) of the Act, as the case may require.

- "18c. Conditions to be stated on endorsement of licence—Where the Chairman of the Commission, in the case of an application for the transfer of a wine maker's licence, or the Commission itself, in the case of an application for the removal of a wine maker's licence, grants the application subject to any condition, that condition shall be included in the endorsement by which the transfer or removal of the licence is effected.
- "18D. Notice of intention to consider cancelling or suspending alcoholic drinks licence—Before considering whether or not it should cancel or suspend an alcoholic drinks licence under section 161L of the Act, the Commission shall give to the holder of the licence a notice in form 44F of its intention to consider the matter."
- **6. Vineyard bar permits**—(1) Regulation 31c of the principal regulations (as inserted by regulation 4 of the Sale of Liquor Regulations 1963, Amendment No. 5) is hereby revoked.

(2) Regulation 4 of the Sale of Liquor Regulations 1963, Amendment

No. 5 is hereby revoked.

- 7. Service of notice of appeal under section 229 of Act—Regulation 32 (1) of the principal regulations is hereby amended by inserting, after the word "section", the words "161M or section 161N or section".
- 8. Notice of sittings and determinations of Licensing Committee—Regulation 46 (3) of the principal regulations is hereby amended by omitting the words "the Medical Officer of Health, and, in the case of a wine maker's licence, the Viticulturist at Auckland,", and substituting the words "and the Medical Officer of Health".
- **9. New forms prescribed**—The First Schedule to the principal regulations is hereby amended by inserting, in their appropriate numerical order, the forms set out in the First Schedule to these regulations.
- 10. Amendments of prescribed forms—(1) Form 24 in the First Schedule to the principal regulations is hereby amended by omitting from the heading the words "WINE MAKER'S", and substituting the words "ALCOHOLIC DRINKS".

(2) Form 26 in that Schedule is hereby amended—

- (a) By omitting the expression "153, and 158", and substituting the expression "158, and 1611":
- (b) By inserting, after the word "the" where it secondly occurs, the words "(or the Chairman of the)":

(c) By revoking the second paragraph.

(3) Form 27 in that Schedule is hereby amended by omitting from the heading the words "WINE MAKER'S", and substituting the words "ALCOHOLIC DRINKS".

(4) Form 28 in that Schedule is hereby amended—

(a) By omitting the expression "154, and 159", and substituting the expression "159, and 161f":

- (b) By inserting, after the words "Licensing Committee" where they first occur, the words "(or Chairman of the Licensing Control Commission)":
- (c) By inserting, after the words "Licensing Committee" where they secondly occur, the words "(or Secretary of the Licensing Control Commission)".
- (5) Forms 32 to 38 in that Schedule are hereby revoked.
- (6) Form 41 in that Schedule is hereby amended by omitting the words "New Zealand".
- (7) Form 56B in that Schedule (as inserted by regulation 7 of the Sale of Liquor Regulations 1963, Amendment No. 5) is hereby revoked.
 - (8) The following regulations are hereby consequentially revoked:
 - (a) Subclause (11), paragraphs (b) to (d) of subclause (14), paragraphs (b) to (d) of subclause (15), and subclause (16), of regulation 6 of the Sale of Liquor Regulations 1963, Amendment No. 5:
 - (b) Subclauses (4) to (7) of regulation 7 of the Sale of Liquor Regulations 1963, Amendment No. 6.
- 11. Fees—The Second Schedule to the principal regulations (as substituted by regulation 8 of the Sale of Liquor Regulations 1963, Amendment No. 5) is hereby amended by omitting the item relating to applications for vineyard bar permits, and substituting the following item:

"On making application for an alcoholic drinks licence (section 161E of the Act) or for the renewal of such a licence (section 161I of the Act) 150."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations are consequential upon the Sale of Liquor Amendment Act 1981 and the Wine Makers Act 1981. By those enactments, the provisions relating to wine makers were removed from the Sale of Liquor Act 1962 and re-enacted (with some amendments) in the Wine Makers Act 1981. Provision for a new licence for the manufacture and sale of certain alcoholic drinks was inserted in the Sale of Liquor Act 1962.

Issued under the authority of the Regulations Act 1936. Date of notification in *Gazette*: 25 March 1982. These regulations are administered in the Department of Justice.
