## THE STABILISATION OF PRICES REGULATIONS 1972, AMENDMENT NO. 6

### THE HON. M. A. CONNELLY PRESIDING IN COUNCIL

Pursuant to the Economic Stabilisation Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Stabilisation of Prices Regulations 1972, Amendment No. 6, and shall be read together with and deemed part of the Stabilisation of Prices Regulations 1972\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the *Gazette*.
- 2. Wholesalers of fresh and frozen meat to make returns—The principal regulations are hereby amended by inserting, after regulation 13c (as inserted by regulation 12 of the Stabilisation of Prices Regulations 1972, Amendment No. 2), the following regulation:

"13D. Every wholesaler of fresh meat or frozen fresh meat, being meat

intended for human consumption in New Zealand, shall-

"(a) Within 7 days after the date of the commencement of this regulation, furnish to the Secretary of Trade and Industry a return in writing setting out the prices charged by him for all such meat on that date; and

- "(b) Within 7 days after any alteration in any price shown in a return made under paragraph (a) of this regulation or under this paragraph, furnish to the Secretary of Trade and Industry a return in writing setting out the prices charged by him for all such meat on the date on which the alteration is made."
- 3. Category A items—(1) The First Schedule to the principal regulations is hereby amended by omitting from the part of clause 1 headed "Foodstuffs and Related Commodities" (as amended by regulation 13 (3) of the Stabilisation of Prices Regulations 1972, Amendment No. 2) the item "Sheep meat, being fresh or frozen fresh meat intended for human consumption in New Zealand which is or contains lamb, hogget, or mutton, including liver and kidneys from such meat".

(2) Regulation 13 of the Stabilisation of Prices Regulations 1972, Amendment No. 2, is hereby consequentially amended by revoking

subclause (3).

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

Regulation 2 requires wholesalers of fresh meat or frozen fresh meat to make a return to the Secretary of Trade and Industry within 7 days after the date of the commencement of the regulations showing the prices being charged by him for such meat on that date, and within 7 days after any alteration in any price shown in that return to make a further return showing the prices charged by him on the date of the alteration.

The effect of regulation 3 is to remove sheepmeat from the list of Category A items in the First Schedule to the principal regulations. Sheepmeat accordingly becomes a Category B item.
