THE STABILISATION OF REMUNERATION REGULATIONS 1972, AMENDMENT NO. 2

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

Pursuant to the Economic Stabilisation Act 1948, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Stabilisation of Remuneration Regulations 1972, Amendment No. 2, and shall be read together with and deemed part of the Stabilisation of Remuneration Regulations 1972* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the

date of their notification in the Gazette.

2. Rate of remuneration under existing instruments to continue in force—Regulation 13 of the principal regulations is hereby amended

by adding the following proviso:

"Provided that where any rate of remuneration in any existing instrument is to continue in force for a period of more than 12 months, and there are special circumstances surrounding the fixation of that period which make it equitable that the rate should not continue in force for the whole of that period, the Remuneration Authority, on the application of any party to the instrument, may consent to that rate continuing in force for a lesser period, ending at least 12 months after the date of coming into operation of that rate."

3. Application of cost of living order to Printing Trades Occupational Class—The principal regulations are hereby amended by inserting, after regulation 27, the following regulation:

"27A. (1) The employing authority in relation to the State employees comprised in the Printing Trades Occupational Class prescribed pursuant to section 41 of the State Services Act 1962 shall, notwith-

standing anything in section 21 of the State Services Remuneration and Conditions of Employment Act 1969, issue an amending determination under that section increasing the rates of remuneration in the pay scale of those employees, on and from the 26th day of October 1972 (the date on which the cost of living order issued under regulation 19 of these regulations took effect), by the amount by which those rates of remuneration would have been increased by that order if that pay scale had been an award.

- "(2) The amending determination issued pursuant to subclause (1) of this regulation shall be deemed to be a determination to which subsection (2) of section 21 of the State Services Remuneration and Conditions of Employment Act 1969 applies.
- "(3) Nothing in subclause (1) of regulation 25 of these regulations shall apply with respect to the amending determination issued pursuant to this regulation or to any order varying or confirming that determination made under subsection (2) of section 21 of the State Services Remuneration and Conditions of Employment Act 1969."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

The effect of regulation 2 is that, where it is equitable to do so, the Remuneration Authority may consent to a rate of remuneration in an existing instrument remaining in force for a period less than that stipulated in the instrument provided that the lesser period is at least 12 months.

The effect of regulation 3 is to apply the cost of living order under regulation 19 to the Printing Trades Occupational Class of the State Services.
