THE SHIPPING (CERTIFICATE OF SERVICE FOR NAVAL OFFICERS) REGULATIONS 1971

ORDER IN COUNCIL

At the Government House at Wellington this 20th day of December 1971

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Shipping and Seamen Act 1952, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Shipping (Certificate of Service for Naval Officers) Regulations 1971.

(2) These regulations shall come into force on the 1st day of January 1972.

2. Interpretation—In these regulations, unless the context otherwise requires,—

“At sea” means outside extended river limits; and “service at sea” means service in a ship plying outside such limits:

“Certificate of service” means a certificate of service issued by the Secretary for Marine in accordance with the provisions of the Act:

“The Act” means the Shipping and Seamen Act 1952:

Expressions defined in the Act have the meanings so defined.

3. Certificate of service—Any person who has served at sea as a commissioned officer of the Seaman Specialisation of the New Zealand Naval Forces may, on application to the Secretary for Marine made on form Marine 3001 accompanied by a fee of \$20, be granted a certificate of service as second mate of foreign-going ship, if he produces to the Secretary for Marine—

- (a) A certificate signed by the Chief of the Naval Staff recommending the issue of such a certificate of service and showing details of at least 4 years' service at sea; and
- (b) An Ocean Navigation Certificate issued by the Royal New Zealand Navy, or a certificate accepted by the Secretary for Marine as equivalent; and

- (c) A first-aid certificate issued by the St. John Ambulance Association, or the New Zealand Red Cross Society, or other body approved by the Secretary for Marine, to the effect that he has passed an examination in first-aid to the injured. The certificate shall be an adult certificate (that is, obtained by the applicant when 16 years of age or more), and the qualifying examination shall have been passed not more than 3 years before the date of the application; and
- (d) Proof of passing the Marine Department standard letter and lantern eyesight test; and
- (e) His birth certificate; and
- (f) A certificate as radar observer in merchant ships, or a certificate issued by the Royal New Zealand Navy accepted by the Secretary for Marine as equivalent.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations provide for the granting to naval officers of certificates of service as second mate of foreign-going ship, subject to compliance with the conditions specified in regulation 2.
