

# THE SUPERANNUATION (DEFINITION OF SALARY) ORDER 1942

# C. L. N. NEWALL, Governor-General. ORDER IN COUNCIL.

At the Government House at Wellington, this 2nd day of September, 1942.

## Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

Pursuant to section 15 of the Finance Act, 1941, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby order as follows:—

1. This Order may be cited as the Superannuation (Definition of Salary) Order 1942.

2. This Order shall be deemed to have come into force on the

27th day of August, 1941.

3. (a) The allowances or classes of allowances specified in the First Schedule hereto shall, with respect to any contributor to the Public Service Superannuation Fund, be deemed to be salary within the meaning of section 2 of the Public Service Superannuation Act, 1927.

(b) The allowances or classes of allowances specified in the Second Schedule hereto shall, with respect to any contributor to the Government Railways Superannuation Fund, be deemed to be pay within the meaning of section 91 of the Government Railways Act, 1926.

(c) The allowances or classes of allowances specified in the Third Schedule hereto shall, with respect to any contributor to the Teachers' Superannuation Fund, be deemed to be salary within the meaning of

section 65 of the Public Service Superannuation Act, 1927.

- 4. If a person who having been a contributor to any of the said Funds was immediately prior to the coming into force of this Order contributing to that Fund in respect of any allowance not specified in the respective Schedule hereto, and such contributor by notice in writing given to the Secretary of the Board administering that Fund, not later than three months after the date of notification of this Order in the Gazette,\* elects to continue to contribute in respect of that allowance, then such allowance shall be deemed to be salary or pay of such contributor within the meaning of the respective section of an Act referred to in clause 3 of this Order.
- 5. The notice in writing referred to in the last preceding regulation may be given, notwithstanding that at the time of the notice the person who gives it is no longer a contributor to any of the said Funds, and in the event of the death of such person may, within the time prescribed by the last preceding regulation, be given by his legal personal representative.

# SCHEDULES.

### FIRST SCHEDULE.

CONTRIBUTORS TO PUBLIC SERVICE SUPERANNUATION FUND.

1. Allowance payable to a contributor to bring his salary or wages to the minimum remuneration for the time being in force in respect of adult officers.

Allowance payable to a contributor to bring his salary or wages to the minimum remuneration for the time being in force in respect of married officers.

3. Special allowances granted in special cases to officers at the maximum of Class VII of the Post and Telegraph Department to bring their remuneration up to £320 per annum or up to £335 per annum.

#### SECOND SCHEDULE.

CONTRIBUTORS TO GOVERNMENT RAILWAYS SUPERANNUATION FUND.

1. Allowance payable to a contributor to bring his salary or wages to the minimum remuneration for the time being in force in respect of adult officers.

2. Allowance payable to contributor to bring his salary or wages to the minimum remuneration for the time being in force in respect of married officers.

### THIRD SCHEDULE.

CONTRIBUTORS TO TEACHERS' SUPERANNUATION FUND.

1. Allowances payable to contributors by way of married allowance.

2. Allowances payable to contributors in respect of extra duties in connection with the supervision of boarders in hostels conducted by education authorities.

3 Allowances payable to contributors in respect of duties as Vocational

Guidance Officer or Careers Teacher.
