

## THE SHIPPING (ENGAGEMENT OF SEAMEN) REGULATIONS 1975, AMENDMENT NO. 1

PURSUANT to sections 41A and 504 of the Shipping and Seamen Act 1952, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

- 1. Title—These regulations may be cited as the Shipping (Engagement of Seamen) Regulations 1975, Amendment No. 1, and shall be read together with and deemed part of the Shipping (Engagement of Seamen) Regulations 1975\* (hereinafter referred to as the principal regulations).
- 2. Postponement of commencement of certain provisions—(1) Regulation 1 (2) of the principal regulations is hereby amended by omitting the words "the 12th day of May 1975", and substituting the words "a date to be appointed for the commencement thereof by the Governor-General by Order in Council".
- (2) Regulation 14 (9) of the principal regulations is hereby consequentially amended by omitting the words "12th day of May 1975", and substituting the words "date appointed for the commencement of this regulation".
- 3. Application for registration—(1) Regulation 9 (1) of the principal regulations is hereby amended by omitting the words "1st day of May 1975", and substituting the words "date appointed for the commencement of regulations 13 to 19 and regulation 22 of these regulations".

(2) Regulation 9 (2) of the principal regulations is hereby amended by omitting the words "on or before the 1st day of May 1975", and substituting the words "before the date appointed for the commencement of regulations 13 to 19 and regulation 22 of these regulations".

## **EXPLANATORY NOTE**

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations postpone the operation of the provisions of regulations 13 to 19 and 22 of the Shipping (Engagement of Seamen) Regulations 1975. These provisions, which were to have come into force on the 12th day of May 1975, set out procedures for the engagement of seamen and make it an offence for employers to engage seamen otherwise than in accordance with those procedures. The provisions will now come into force on a date to be appointed by the Governor-General by Order in Council.

In addition these regulations extend, until the date so appointed, the time within which certain categories of seamen may register in Register A. The closing date in the regulations as originally enacted was the 1st day of May 1975.
