THE SANITARY PLUMBING (COUNTIES) NOTICE 1968

PURSUANT to section 38 (3) of the Plumbers and Gasfitters Registration Act 1964, the Minister of Health hereby gives the following notice.

NOTICE

1. (1) This notice may be cited as the Sanitary Plumbing (Counties) Notice 1968.

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

2. The operation of section 38 of the Plumbers and Gasfitters Registration Act 1964 is hereby suspended within the parts of the counties specified in the Schedule hereto from the commencement of this notice until the expiration of the 31st day of December 1970.

corner of Lot 24, D.P. 18105; thence south-easterly, westerly, and again south-easterly along the eastern and southern boundaries of Lots 24 and 21, D.P. 18105, to the southernmost extremity of Lot 21, D.P. 18105; thence southerly by a right line to the northernmost corner of Lot 17, D.P. 25239; thence southerly by a right line to the northernmost corner of Lot 7, D.P. 9176; thence south-easterly along the north-east boundary of that Lot to a point $2\frac{1}{2}$ chains at right angles from the northern side of Travis Road; thence easterly along a line parallel to and $2\frac{1}{2}$ chains north of the north side of Travis Road to the eastern boundary of Lot 5, D.P. 9176; thence southerly along that boundary and its production to the middle line of Travis Road being a point on the boundary of the County of Waimairi; thence westerly generally along that county boundary to the point of commencement; thirdly, all that area bounded by a line commencing at the intersection of the middle lines of Beach and Frosts Roads being a point on the boundary of the County of Waimairi and proceeding northerly and north-westerly along the middle line of Mairehau Road to a point in line with the western boundary of Lot 7, D.P. 21474; thence north-easterly to and along that boundary and its production to a point in line with the southern boundary of Rural Section 7005; thence easterly to and along that boundary and its production to the western side of Bower Avenue; thence southerly along that roadside to a point in line with the northern boundary of Lot 3, D.P. 19967; thence easterly and southerly generally to and along that boundary and the northern and eastern boundaries of Lots 1 and 2, D.P. 19967, and the production of the last mentioned boundary to the middle of Florence Avenue being a point on the boundary of the County of Waimairi; thence westerly generally along that County boundary to the point of commencement; fourthly, all that area bounded by a line commencing at a point on the middle line of Beach Road in line with the eastern boundary of Lot 1, D.P. 16752, being a point on the boundary of the County of Waimairi, and proceeding northerly to and along the eastern boundary of Lot 1, D.P. 16752, and its production to the southern side of Rothesay Road; thence easterly along that roadside and its production to the mean high-water mark of the sea being a point on the boundary of the County of Waimairi; thence southerly and westerly by that County boundary to the point of commencement.

Gazette</i>, 1962, p. 866, on the right bank of the Whakatane River, and proceeding northerly along that bank to the shore of the Bay of Plenty; thence northerly and south-easterly generally along that shore to the western shore of the entrance to the Ohiwa Harbour; thence southerly and westerly generally along the shore of that harbour to a point in line with the southern boundary of part Allotment 248, Waimana Parish, along a right line across a public road, to and along the aforesaid boundary, the southern and western boundaries of Allotment 247, Waimana Parish, the north-eastern boundary of part Lot 6, D.P. 10440, a right line across Maraetotara Road, to and along the south-western boundary of Lot 2, D.P. 23762, and its production to and along the north-eastern side of Wainui Stock Road, to the south-eastern boundary of the Borough of Whakatane aforesaid; thence northerly along that boundary to the point of commencement.</p>

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

The effect of this notice is to suspend the operation of section 38 of the Plumbers and Gasfitters Registration Act 1964 within the parts of the counties mentioned in the Schedule to the notice until the 31st day of December 1970 so that until that date persons residing in the parts of the counties mentioned will not be able to do sanitary plumbing in their own homes and will be required to engage a registered plumber for that work.
