## THE SANITARY PLUMBING (COUNTIES) NOTICE 1971

---

PURSUANT to section 38 (3) of the Plumbers and Gasfitters Registration Act 1964, the Minister of Health hereby gives the following notice.

---

### NOTICE

**1. Title and commencement**—(1) This notice may be cited as the Sanitary Plumbing (Counties) Notice 1971.

(2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

**2. Operation of section 38 suspended**—The operation of section 38 of the Plumbers and Gasfitters Registration Act 1964 is hereby suspended within the counties specified in Part I of the Schedule hereto and within the parts specified in the second column of Part II of the Schedule hereto of the counties specified in the first column of that Part from the commencement of this notice until the expiration of the 30th day of June 1972.

## EXPLANATORY NOTE

*This note is not part of the notice, but is intended to indicate its general effect*

This notice suspends the operation of section 38 of the Plumbers and Gasfitters Registration Act 1964 within the counties and the parts of the counties mentioned in the Schedule to the notice until the 30th day of June 1972. The effect of the suspension is that until that date persons residing in the counties and the parts of the counties mentioned will not be able to do sanitary plumbing in their own homes and will be required to engage a registered plumber for that work.
