

THE SANITARY PLUMBING (COUNTIES) NOTICE 1975

PURSUANT to section 38 (3) of the Plumbers and Gasfitters Registration Act 1964, the Minister of Health hereby gives the following notice.

NOTICE

- 1. Title and commencement—(1) This notice may be cited as the Sanitary Plumbing (Counties) Notice 1975.
 - (2) This notice shall come into force on the 1st day of January 1976.
- 2. Operation of section 38 suspended—The operation of section 38 of the Plumbers and Gasfitters Registration Act 1964 is hereby suspended, from the commencement of this notice until the expiration of the 30th day of June 1978, within those areas of the counties mentioned in the first column of the First Schedule to this notice as are specified in the second column of that Schedule.
- **3.** Revocations—The notices specified in the Second Schedule to this notice are hereby consequentially revoked.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice suspends the operation of section 38 of the Plumbers and Gasfitters Registration Act 1964 within the areas described in the First Schedule until the 1st day of July 1978. The effect of the suspension is that until that date persons residing in any of those areas will not be able to do sanitary plumbing in their own houses, and will be required to engage a registered plumber for that work.
