#### ORDER IN COUNCIL

At Wellington this 20th day of July 1987

### Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL
PURSUANT to section 212 of the Summary Proceedings Act 1957, His
Excellency the Governor-General, acting by and with the advice and
consent of the Executive Council, hereby makes the following regulations.

## REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Summary Proceedings Regulations 1958, Amendment No. 15, and shall be read together with and deemed part of the Summary Proceedings Regulations 1958\* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 1st day of August 1987.
- 2. Forms amended—(1) Form 7A in the First Schedule to the principal regulations (as inserted by regulation 3 (1) (b) of the Summary Proceedings Regulations 1958, Amendment No. 7) is hereby amended by revoking the

certificate of consent to bail by the Court, and substituting the following certificate:

"CERTIFICATE OF GRANT OF BAIL  I hereby certify that I have granted bail to the said, subject to the following condition(s):

District Court Judge."
(2) Form 11 in the First Schedule to the principal regulations is hereby amended by revoking the certificate of consent to bail by the Court or Justice remanding the prisoner, and substituting the following certificate:
"CERTIFICATE OF GRANT OF BAIL  I (WE) hereby certify that I (we) have granted bail to the said, subject to the following condition(s):
District Court Judge (or Justice(s))."

- (3) Forms 12, 12A, 13, and 14 in the First Schedule to the principal regulations (as substituted by regulation 3 (1) (d) of the Summary Proceedings Regulations 1957, Amendment No. 7) are hereby revoked.
- (4) The First Schedule to the principal regulations is hereby further amended by revoking form 16, and substituting the form 16 set out in the Schedule to these regulations.
- (5) Forms 17 to 20 in the first Schedule to the principal regulations are hereby revoked.
- (6) Regulation 3 (1) (d) of the Summary Proceedings Regulations 1958, Amendment No. 7 is hereby revoked.

#### **EXPLANATORY NOTE**

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations make various changes in respect of the forms prescribed under and for the purposes of the Summary Proceedings Act 1957. All the changes are consequential upon changes to the law relating to bail effected by the Summary Proceedings Amendment Act (No. 3) 1987, which formerly comprised part of the Violent Offences Bill (No. 2).
