ORDER IN COUNCIL

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 212 of the Summary Proceedings Act 1957, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Summary Proceedings Regulations 1958, Amendment No. 17, and shall be read together with and deemed part of the Summary Proceedings Regulations 1958* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 11th day of April 1988.
- 2. Default in payment of sum adjudged to be paid on conviction—Regulation 15H(1) of the principal regulations (as inserted by regulation 2 of the Summary Proceedings Regulations 1958,

Amendment No. 7) is hereby amended by omitting the expression "\$50" (as substituted by regulation 2 of the Summary Proceedings Regulations 1958, Amendment No. 12), and substituting the expression "\$55".

- **3. Court fees**—The principal regulations are hereby amended by revoking the Second Schedule (as substituted by regulation 2 of the Summary Proceedings Regulations 1958, Amendment No. 14), and substituting the Second Schedule set out in the Schedule to these regulations.
- **4. Goods and services tax included**—The fees prescribed by these regulations are inclusive of goods and services tax under the Goods and Services Tax Act 1985.
- **5. Revocations**—The following regulations are hereby consequentially revoked, namely:

NOTE—(1) Where pursuant to any enactment several offences are charged in the one information (not being offences charged in the alternative), the fees to be taken shall be assessed as if separate informations had been laid in respect of the several offences charged.

(2) The foregoing fees are not to be taken in proceedings under the Family Proceedings Act 1980, or in proceedings by way of complaint or in proceedings under Part V of the Summary Proceedings Act 1957."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 11 April 1988, prescribe the Court fees payable under the Summary Proceedings Regulations 1958.

The fee payable in respect of the issue of a summons or warrant where default is made in the payment of a sum adjudged to be paid on a conviction is increased from \$50 to \$55.

The hearing fee in respect of any information or charge is increased from \$30 to \$40. All of the fees prescribed by these regulations are inclusive of goods and services tax.
