## HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 212 of the Summary Proceedings Act 1957, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

#### REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Summary Proceedings Regulations 1958, Amendment No. 25, and shall be read together with and deemed part of the Summary Proceedings Regulations 1958\* (hereinafter referred to as the principal regulations).

**2. Forms amended**—(1) Form 5 in the First Schedule to the principal regulations is hereby amended by omitting the expression "Section 19 (c)", and substituting the expression "Section 19 (1) (c)".

(2) Form 5B in the First Schedule to the principal regulations (as inserted by regulation 3 of the Summary Proceedings Regulations 1958, Amendment No. 18) is hereby amended by omitting the expression "Children and Young Persons Court", and substituting the expression "Youth Court".

(3) Form 7 in the First Schedule to the principal regulations is hereby amended—

(a) By inserting, after the words "District Court Judge" where they first appear, the words "(or Registrar)":

(b) By inserting, after the words "District Court Judge" where they last appear, the words "or a Registrar".

(4) Form 11 in the First Schedule to the principal regulations (as amended by regulation 2 of the Summary Proceedings Regulations 1958, Amendment No. 15) is hereby amended—

- (a) By inserting, after the words "or Justice(s) of the Peace", the words "or Registrar":
- (b) By inserting, after the words "or Justice(s)" where they last appear, the words "or Registrar".

(5) Form 21 in the First Schedule to the principal regulations is hereby amended by inserting, after the words "or Justice(s) of the Peace" wherever they occur, the words "or Registrar".

(6) Form 21A in the First Schedule to the principal regulations (as inserted by regulation 2 (1) of the Summary Proceedings Regulations 1958, Amendment No. 23) is hereby amended by inserting, after the words "or Justice(s) of the Peace", the words "or Registrar".

(7) Form 30 in the First Schedule to the principal regulations (as substituted by regulation 3 (2) of the Summary Proceedings Regulations 1958, Amendment No. 16) is hereby amended—

- (a) By omitting the expression "9 hours", and substituting the expression "10 hours":
- (b) By omitting the expression "15 hours", and substituting the expression "18 hours".

(8) Form 31A in the First Schedule to the principal regulations (as inserted by regulation 2 (2) of the Summary Proceedings Regulations 1958, Amendment No. 23) is hereby amended by omitting the words "until such time as the Registrar advises the Constable or Bailiff that the defendant has not complied with the conditions imposed at the time of the order", and substituting the words "by a Constable or Bailiff until such time as the defendant ceases to comply with any of the conditions of the order".

#### EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 1996, amend a number of the forms contained in the First Schedule to the Summary Proceedings Regulations 1958.

The amendments are mainly consequential on the enactment of the Criminal Justice Amendment Act 1993, the Summary Proceedings Amendment Act 1993, and the Summary Proceedings Amendment Act 1995.

In particular, the amendments take account of changes to the Summary Proceedings Act 1957 which confer increased powers on Registrars.
