HER EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to section 80 of the Survey Act 1986, Her Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Surveyors Professional Regulations 1977, Amendment No. 3, and shall be read together with and deemed part of the Surveyors Professional Regulations 1977* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the 28th day after the date of their notification in the Gazette.
- 2. Fees—The principal regulations are hereby amended by revoking regulation 36 (as substituted by regulation 2 of the Surveyors Professional Regulations 1977, Amendment No. 2), and substituting the following regulation:

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on the 28th day after the date of their notification in the *Gazette*, increase the fees payable to the Survey Board of New Zealand. The new fees are inclusive of goods and services tax. The previous fees were set in 1985.
