Pursuant to section 15 of the Shearers Act 1962, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

- 1. Title and commencement—(1) These regulations may be cited as the Shearers Regulations 1963, Amendment No. 1, and shall be read together with and deemed part of the Shearers Regulations 1963* (hereinafter referred to as the principal regulations).
- (2) These regulations shall come into force on the day after the date of their notification in the Gazette.
- 2. Metric amendments—The principal regulations are hereby amended in the manner indicated in the Schedule to these regulations.
- 3. Savings—In relation to facilities constructed before the commencement of these regulations, the principal regulations shall be read as if these regulations had not been made.
