



## THE SHIPPING (FEES) REGULATIONS 1988, AMENDMENT NO. 1

### ORDER IN COUNCIL

At Wellington this 12th day of December 1988

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to sections 501 and 504 of the Shipping and Seamen Act 1952, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

### REGULATIONS

**1. Title and commencement**—(1) These regulations may be cited as the Shipping (Fees) Regulations 1988, Amendment No. 1, and shall be read together with and deemed part of the Shipping (Fees) Regulations 1988\* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the 28th day after the date of their notification in the *Gazette*.

**2. Fees for inspection of ship radios increased**—(1) Part I of Section B of the First Schedule to the principal regulations is hereby amended by omitting from the item in paragraph (a) relating to inspections by Radio Surveyors the expression "\$143", and substituting the expression "\$214.50".

(2) Part II of Section B of the First Schedule to the principal regulations is hereby amended—

(a) By omitting from item (a) the expression “214.50”, and substituting the expression “330”:

(b) By omitting from item (b) the expression “142”, and substituting the expression “214.50”.

(3) Part III of Section B of the First Schedule to the principal regulations is hereby amended by omitting from the item in paragraph (a) relating to inspections by Radio Surveyors the expression “\$99”, and substituting the expression “\$148.50”.

(4) Part XV of Section D of the First Schedule to the principal regulations is hereby amended by omitting the words “Where, before the issue of any of the permits referred to above, it is necessary for the radio installation to be inspected by a Radio Surveyor, there shall be payable an additional fee of \$70”, and substituting the words “Where, before the issue of any of the dispensations or the exemption referred to above, it is necessary for the radio installation to be inspected by a Radio Surveyor, there shall be payable an additional fee of \$148.50”.

#### EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations, which come into force 28 days after their notification in the *Gazette*, increase fees for inspections carried out on ships by Radio Surveyors.

The following increases are effected:

- (a) The additional fee for an inspection of a radio installation, where it is done for the purposes of the issue of a certificate of survey as a restricted-limit ship or as a fishing boat, is increased from \$143 to \$214.50:
- (b) The fee for the issue of a radio certificate on a ship fitted with radiotelegraphy equipment is increased from \$214.50 to \$330:
- (c) The fee for the issue of a radio certificate on a ship fitted with radiotelephony equipment is increased from \$142 to \$214.50:
- (d) The additional fee for the inspection of a radio installation for the purposes of extending a certificate of survey is increased from \$99 to \$148.50:
- (e) The fee for the inspection of a radio installation, before the granting of exemptions or dispensations under the Shipping and Seamen Act 1952, is increased from \$70 to \$148.50.
