THE SHIPPING RESTRICTED LIMITS NOTICE 1953, AMENDMENT NO. 3

PURSUANT to the Shipping and Seamen Act 1952, the Minister of Marine hereby gives the following notice.

NOTICE

- 1. (1) This notice may be cited as the Shipping Restricted Limits Notice 1953, Amendment No. 3, and shall be read together with and deemed part of the Shipping Restricted Limits Notice 1953* (hereinafter referred to as the principal notice).
- (2) This notice shall come into force on the seventh day after its notification in the Gazette.
- 2. (1) The Schedule to the principal notice (as amended by the Shipping Restricted Limits Notice 1953, Amendment No. 2) is hereby further amended by omitting so much thereof as relates to the ports of Breaksea Sound and Dusky Sound, Doubtful Inlet, Milford Sound, and Preservation Inlet.
- (2) The Schedule to the principal notice is hereby further amended by inserting, after the reference to the Port of Bay of Islands, the following words:

"Bay of Plenty— Hauraki Gulf (whaling limits only)	Nil	 	••••	 For whaling vessels only: Within an area enclosed by a right line drawn from the easternmost extremity of Taiharuru Point to a position 11 miles north-east (true) from the extremity of Needles Point, Aiguilles Island (off north end of Great Barrier); thence by a right line in a south-easterly direction to a position 1 mile east of Plate Island; thence by a right line to the north-
				ernmost extremity of Town Point."

(3) The Schedule to the principal notice is hereby further amended by inserting, after the reference to the Port of Dunedin and Port Chalmers, the following words:

Inside a right line drawn from Febrero Point to South West Point of Secretary Islands

Inside a right line drawn 078° from St. Anne Point to the point 2 miles northward of Dale Point in Milford Sound Harbour

Inside a right line drawn from the southernmost extremity of Burnett

southernmost extremity of Burnett Point to the northernmost point of Anxiety Point Inside a right line drawn from Cavern Head to Pinnacle Rock, Coal Island, and inside a right line drawn across the entrance to Otago's Retreat at its narrowest width Inside a right line grawn from the northernmost point of Colonial Head to the westernmost extremity of

to the westernmost extremity of Shanks Head

Inside a right line drawn from the eastern extremity of Milford Sound river limits to a position 1 sea mile north of St. Anne Point light; thence inside a line 1 mile to seaward of and parallel to the coast to Shanks Head; and thence by a right line to the northernmost extremity of Colonial Head (Thompson Sound Colonial Head (Thompson

tremity of Colonial Head (Thompson Sound).
Inside a right line drawn from South West Point on Secretary Island to a position 1 mile seaward of Febrero Point; thence inside a line 1 mile to seaward of and parallel to the coast to the northern shore of Breaksea Island and inside a right line drawn (southward) from the westernmost point of Breaksea Island to the shore of Resolution Island.
Inside a right line from the south-

Island.

Inside a right line from the southernmost point of Five Fingers Point to a position 1 mile to seaward of South Point; thence inside a line 1 mile to seaward of and parallel to the coast to a position 1 mile seaward of the westernmost rock of Providence Rocks; thence inside a right line to the westernmost point of Chalky Island; thence inside a right line from the southernmost extremity of Chalky Point to Puysegur Point Lighthouse.

(During daylight hours and in fine weather only)."

(4) The Shipping Restricted Limits Notice 1953, Amendment No. 2, is hereby revoked.

EXPLANATORY NOTE

This note is not part of the notice, but is intended to indicate its general effect.

This notice prescribes river limits and extended river limits for the ports in Fiordland, also whaling limits for Bay of Plenty and Hauraki Gulf.
