HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL

PURSUANT to the Stock Act, 1908, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, doth hereby make the following regulations.

REGULATIONS

1. These regulations may be cited as the Sheep Return Regulations 1951.
2. The return referred to in section 52 of the Stock Act, 1908, shall be in the form set out in the Schedule hereto.
3. The regulations prescribing the form of the return of sheep made on the 22nd day of March, 1897, and published in the *Gazette* of the 25th day of March, 1897, at page 734, are hereby revoked.
