Regulations

1 Title

These regulations are the Social Security (Temporary Additional Support) Amendment Regulations 2007.

2 Commencement

These regulations come into force on 1 April 2007.

3 Principal regulations amended

These regulations amend the Social Security (Temporary Additional Support) Regulations 2005.

4 Schedule 2 amended

Each provision of Schedule 2 of the principal regulations listed in the first column of the Schedule of these regulations is amended by—

- (a) omitting the amount set out opposite to it in the second column; and
- (b) substituting the amount set out opposite to it in the third column.

5 Consequential revocation

Regulation 5 and Schedule 2 of the Social Security (Temporary Additional Support) Amendment Regulations 2006 (SR 2006/48) are consequentially revoked.

Explanatory note

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations, which come into force on 1 April 2007, amend Schedule 2 of the Social Security (Temporary Additional Support) Regulations 2005.

The amendments increase the limits on certain allowable costs for which temporary additional support may be granted.
