**THE SECONDARY SCHOOL BOARDS ADMINISTRATION AND
EMPLOYMENT REGULATIONS 1965, AMENDMENT NO. 2**

ORDER IN COUNCIL

At the Government House at Wellington this 20th day of November 1972

Present:

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title—These regulations may be cited as the Secondary School Boards Administration and Employment Regulations 1965, Amendment No. 2, and shall be read together with and deemed part of the regulations heretofore cited as the Secondary School Boards Administration Regulations 1965* (hereinafter referred to as the principal regulations).

2. Alterations of titles of principal regulations and amending regulations—(1) The principal regulations may hereafter be cited as the Secondary School Boards Administration and Employment Regulations 1965.

(2) The title of the principal regulations and the title of the Secondary School Boards Administration Regulations 1965, Amendment No. 1, are hereby consequentially amended in each case, by inserting, after the word "Administration", the words "and Employment".

3. Interpretation—Regulation 2 of the principal regulations is hereby amended by omitting from the definition of the term "Board", the words "Parts II and III", and substituting the words "Parts II, III, and VI".

4. Conditions of employment of board employees—(1) The principal regulations are hereby amended by inserting after regulation 59, the following Part:

“PART VI—SALARIES AND CONDITIONS OF EMPLOYMENT OF
BOARD EMPLOYEES

“59A. (1) The provisions of the Education Boards’ Employment Regulations 1958* shall, with the necessary modifications, apply to secondary school boards and secondary school councils in every way as if the boards and councils were Boards within the meaning and for the purposes of those regulations.

“(2) The provisions of the Education Boards’ Employment Regulations 1958 shall, with the necessary modifications, apply to persons employed by a secondary school board or secondary school council where the conditions of employment of those persons are not for the time being fixed by any award of the Court of Arbitration, or by any industrial agreement entered into under the Industrial Conciliation and Arbitration Act 1954, or by any order made by the Court of Arbitration under section 13 of the Apprentices Act 1948, or by any order or determination made under the State Services Remuneration and Conditions of Employment Act 1969, in every way as if those persons were employed by a Board within the meaning and for the purposes of the Education Boards’ Employment Regulations 1968.

“(3) Notwithstanding anything in subclause (1) or subclause (2) of this regulation, the provisions of the Education Boards’ Employment Regulations 1958 shall not apply to persons employed as caretakers, cleaners, groundsmen, teachers aides, nursing aides, library assistants, or laboratory assistants.

“(4) Notwithstanding anything in subclause (1) or subclause (2) of this regulation, the Education Boards’ Employment Regulations 1958 shall not apply to any officer of any secondary school board or secondary school council that derives a substantial part of its income from other than a government source if, on application made to the Minister by the board or council, together with the written consent of the officer, the Minister so decides that those regulations shall not apply; but at no time shall more than 1 officer of the same school board or council be the subject of any decision or decisions under this subclause.”

(2) The Education Boards’ Employment Regulations 1958 are hereby consequentially amended by inserting in regulation 3, before the words “These regulations”, the words “Subject to Part VI of the Secondary School Boards Administration and Employment Regulations 1965 (as inserted by regulation 4 of the Secondary School Boards Administration and Employment Regulations 1965, Amendment No. 2),”.

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations change the title of the principal regulations to the Secondary School Boards Administration and Employment Regulations 1965. A new Part VI is inserted in the principal regulations, relating to salaries and conditions of employment of Board employees.
