PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. Title and commencement—(1) These regulations may be cited as the Secondary School Boards Administration and Employment Regulations 1965, Amendment No. 7 and shall be read together with and deemed part of the Secondary School Boards Administration and Employment Regulations 1965* (hereinafter referred to as the principal regulations).

(2) These regulations shall come into force on the day after the date of their notification in the Gazette.

2. Election of members by parents—Regulation 7 (2) of the principal regulations is hereby amended by omitting the words "1st day of April and not later than the 23rd day of May", and substituting the words "1st day of June and not later than the 23rd day of July".

3. Election of members by school committees—Regulation 8 (2) of the principal regulations is hereby amended by omitting the word "May", and substituting the word "July".

4. Election of representatives of Associations of employers and employees—Regulation 9 (2) of the principal regulations is hereby amended by omitting the word "May", and substituting the word "July".

5. Tenure of Office—Regulation 17 of the principal regulations, as amended by regulation 2 of the Secondary School Boards Administration Regulations 1965, Amendment No. 1 is hereby further amended by omitting, in both places where they occur, the words "31st day of May", and substituting, in each case, the words "31st day of July".

6. Assumption of office—Regulation 19 of the principal regulations is hereby amended by omitting the words "1st day of June", and substituting the words "1st day of August".

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

These regulations amend the principal regulations by changing the month in which election of Board members shall be held from May to July, and consequentially changing the dates of commencement and tenure of office.
