THE SOCIAL SECURITY (MATERNITY BENEFITS)

ORDER IN COUNCIL

At the Government Buildings at Wellington this 4th day of April 1961

Present:

THE RIGHT HON. KEITH HOLYOAKE, PRESIDING IN COUNCIL

PURSUANT to the Social Security Act 1938, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Social Security (Maternity Benefits) Regulations 1939, Amendment No. 7, and shall be read together with and deemed part of the Social Security (Maternity Benefits) Regulations 1939* (hereinafter referred to as the principal regulations).

2. (1) The principal regulations are hereby amended by revoking the Schedule, as substituted by subclause (1) of regulation 2 of the Social Security (Maternity Benefits) Regulations 1939, Amendment No. 6, and substituting the new Schedule set out in the Schedule to these regulations.

(2) The Social Security (Maternity Benefits) Regulations 1939, Amendment No. 6, are hereby revoked.

3. (1) These regulations shall apply in every case where the maternity benefits are afforded on the 1st day of April 1961 or any later date.

(2) In all other cases the principal regulations shall apply as if these regulations had not been made.

NEW SCHEDULE TO PRINCIPAL REGULATIONS

"SCHEDULE

PART I

Fees Payable to Hospital Boards

1. In respect of the day of the birth of the child and each of the 14 days succeeding that day, the amount of £1 15s. 6d. a day.

2. In respect of any patient actually attended during labour and at delivery by a medical officer employed by the Hospital Board, an additional fee of £2.

PART II

Fees Payable to Licensees of Licensed Maternity Hospitals

In respect of the day of the birth of the child and each of the 14 days succeeding that day, the amount of £1 15s. 6d. a day."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

The Schedule to the principal regulations provides for fees to be paid to Hospital Boards and licensees of licensed maternity hospitals in respect of maternity services provided.

These regulations increase the daily fees payable from £1 12s. 6d. to £1 15s. 6d. as from 1 April 1961.
