**THE SOCIAL SECURITY (PHYSIOTHERAPY BENEFITS)
REGULATIONS 1951, AMENDMENT NO. 2**

ORDER IN COUNCIL

At the Government House at Wellington this 18th day of April 1956

Present:

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL

PURSUANT to the Social Security Act 1938, His Excellency the Administrator of the Government, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. These regulations may be cited as the Social Security (Physiotherapy Benefits) Regulations 1951, Amendment No. 2, and shall be read together with and deemed part of the Social Security (Physiotherapy Benefits) Regulations 1951* (hereinafter referred to as the principal regulations).

2. (1) Regulation 9 of the principal regulations is hereby amended as follows:

(a) By inserting, before the words "Where any physiotherapist" at the beginning of subclause (1), the words "Subject to the provisions of this regulation":

(b) By revoking the proviso to subclause (1).

(2) The said regulation 9 is hereby further amended by inserting, after subclause (1), the following subclause:

"(1A) No contractor shall be entitled to receive from the Fund more than one fee in respect of the same person for treatment given on any one day, whether the treatment is given to that person individually or as a member of a group:

"Provided that in any special case, with the approval of the Director-General of Health, two fees may be paid in respect of the same person for treatments given on any one day."

(3) Regulation 5 of the Social Security (Physiotherapy Benefits) Regulations 1951, Amendment No. 1†, is hereby consequentially amended by revoking paragraph (b).

3. (1) Regulation 9A of the principal regulations, as inserted by regulation 6 (1) of the *Social Security (Physiotherapy Benefits) Regulations 1951, Amendment No. 1*, is hereby amended as follows:

(a) By inserting, before the word "Where" at the beginning of subclause (1), the words "Subject to the provisions of this regulation":

(b) By revoking the proviso to subclause (1).

(2) The said regulation 9A is hereby further amended by inserting, after subclause (1), the following subclause:

"(1A) No contractor shall be entitled to receive from the Fund more than one fee in respect of the same person for treatment given on any one day, whether the treatment is given to that person individually or as a member of a group:

"Provided that in any special case, with the approval of the Director-General of Health, two fees may be paid in respect of the same person for treatments given on any one day."

EXPLANATORY NOTE

This note is not part of the regulations, but is intended to indicate their general effect.

The principal regulations provide that not more than one fee is payable from the Social Security Fund in respect of the same person for treatment given on any one day. This amendment authorises payment of two fees for treatments given to a person on one day in special cases approved by the Director-General of Health.
