THE HON. H. WATT PRESIDING IN COUNCIL

PURSUANT to the Education Act 1964, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following regulations.

REGULATIONS

1. **Title**—These regulations may be cited as the Secondary School Grants Regulations 1967, Amendment No. 4, and shall be read together with and deemed part of the Secondary School Grants Regulations 1967\* (hereinafter referred to as the principal regulations).

2. **Grants for general expenses**—(1) Regulation 3 of the principal regulations (as amended by regulation 2 of the Secondary School Grants Regulations 1967, Amendment No. 3) is hereby further amended by revoking paragraph (a) of subclause (1), and substituting the following paragraph:

“(a) A grant which shall be applied in accordance with regulation 6 of these regulations, and which shall be ascertained in accordance with the following scale:

“*Normal Day Classes*

Number of Pupils for Each School Under the Governing Body	Yearly Rate of Payment per Pupil \$
For the first 100 pupils .....	40.50
For the next 200 pupils .....	24.80
For the next 300 pupils .....	16.95
For all pupils in excess of 600 .....	14.20

*“Technical or Continuation Day  
or Evening Classes*

For all in classes that are vocational in excess of 400	21”

(2) Notwithstanding anything in subclause (1) of this regulation, the grants payable under paragraph (a) of subclause (1) of regulation 3 of the principal regulations (as amended by subclause (1) of this regulation) for the period from the commencement of these regulations until the 31st day of January 1973 shall be at a rate necessary to reduce the grants payable for the whole of the year ending with that date to an amount equal to that which would have been payable if the grants prescribed under that subclause were apportioned so as to be payable for only 10 months of that year, and the grants payable under the said paragraph (a) immediately before the commencement of these regulations were apportioned so as to be payable for only the remaining 2 months of the year.

(3) Regulation 2 of the Secondary School Grants Regulations 1967, Amendment No. 3, is hereby consequentially revoked.

EXPLANATORY NOTE

*This note is not part of the regulations, but is intended to indicate their general effect.*

These regulations amend the Secondary School Grants Regulations 1967 by increasing grants to the governing bodies of secondary schools in respect of normal day classes.
